

ORDINANCE NO. 03122019

AN ORDINANCE OF THE CITY OF ENCINAL, TEXAS DECLARING THE UNOPPOSED CANDIDATES FOR MAYOR AND FIVE CITY COUNCIL MEMBERS AT-LARGE, PROVIDING THAT THE MAY 4, 2019. GENERAL MUNICIPAL ELECTION OF OFFICERS SHALL NOT BE HELD; CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, a general election of municipal officers was ordered to be held on May 4, 2019, for the purpose of electing five officials of the City of Encinal, to wit: Mayor and Five City Council Members At-Large and

WHEREAS, pursuant to Section 2.052, Texas Election Code, the deadline for filing as application for a place on the ballot in each of those elections and the deadline for filing as a write-in candidate in each of those elections has expired; and

WHEREAS, the City Secretary, in accordance with Election 2.052, Texas Election Code, has certified to the City Council in which that each person listed herein is unopposed for election to the office to which he or she is hereby declared elected; and

WHEREAS, the City Council hereby finds and determines that each candidate whose name is to appear on the ballot in each of said elections is unopposed, and there are no declared write-ins, and if said elections were held, only the votes cast for the candidates herein listed could be counted; and no proposition is to appear on the ballots for each election, now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ENCINAL, TEXAS:

Section 1. The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct.

Section 2. In accordance with Section 2.053 of the Texas Election Code, the following unopposed candidates are hereby declared duly elected to the respective offices shown for a four-year term and until their respective successors in office and duly qualified.

- Mayor: Sylvano Sanchez
- Councilwoman, Irma Arizola
- Councilman, Roberto Aldaco
- Councilwoman, Brianda Renteria
- Councilman, Sonny Aldaco

Section 3. Pursuant to Section 2.053 (b), Texas Election Code, the general election of municipal officers is ordered by City of Encinal, Texas for May 4, 2019, shall not be held and are hereby canceled.

Section 4. The City Secretary is hereby directed to cause a copy of this Ordinance to be posted on election day, same being May 4, 2019, at polling places that would have been used in such election.

Section 5. If any part of this ordinance, or whatever size, is ever declared invalid or unenforceable for any reason, the remainder of this ordinance shall remain in full force and effect.
