Another issue that came up was that Hecho en Encinal is still in need of funding in the amount of \$15000.00. EEDC is paying part of it and discussion was brought up by Interim City Manager Velma Davila that there may be a possibility that we would be able to help them out with half of that amount. City of Encinal would consider but nothing was agreed upon.
- 7. Discuss formation of 501c3 and other information acquired for EMS services in Encinal. City Council member Frank Weikel got firsthand experience with this issue because during the night his wife Debra got ill and needed emergency services, after calling 911 he was told that the patient would have to be transported to Dilley not Laredo. Mr. Weikel was very upset about the situation, his only other option would be to drive the patient to the Webb County line and that they would be able to pick up a patient there. Mr. Santos was present and also mentioned that he knew of certain companies operating out of Laredo and option would be to put a ½ cent increase in Sales Tax so funds could be made available. Interim City Manager Velma Davila mentioned that she may know a private entity out of Laredo that might be able to work with us. City Council Member Frank Weikel just wants something to get done about this issue. Mr.

Mancha will see if he can set up a meeting with County Commissioner's Canales and Richard Garza. End of discussion.

- 1. Call to order. Meeting was called to order by Mayor Sylvano Sanchez and let the record show that a quorum is present. Meeting was called to order at 5:01 p.m. Present were Council Members Antonio Nieto, Frank Weikel, and Josie Poncedeleon. Another item of interest was the Fire and Response Grant Program that has been applied for by the City, if this item is granted it would create jobs for one full time and two part time Firefighters. To conclude Ms. Davila mentioned that that we got a call from a concerned citizen about needing a security light on the corner of Holcomb and French Streets because there seems to be a lot of activity going on around there at night. - 1. Call to Order. Meeting was called to order by Mayor Sylvano Sanchez at 5:00 p.m.
- 2. **Roll Call & Pledge of Allegiance**. Present were all Council members: Antonio Nieto, Rosa Rivera, Frank Weikel, and Irma Arizola. Pledge of Allegiance was led by Mayor Sanchez.

- 1. Call to Order. Meeting was called to order by Mayor Sylvano Sanchez at 5:01 p.m. present were Council Members: Rosa Rivera, Irma Arizola, and Antonio Nieto. Mayor Sanchez advised Council Members that Council Member Frank Weikel was running a little bit late but that he would be here. After roll call Mayor Sanchez determined that there had been a quorum established and the meeting could proceed.
- 2. Pledge of Allegiance. Pledge of Allegiance was led by Council Members.
- 3. Consent Agenda. Approval of minutes for meeting held on April 24, 2012. The consent agenda was tabled due to the fact that there was a mix up on the date of the minutes being approved. A motion was made by Council Member Antonio Nieto to table the approval of the minutes and a second motion was made by Council Member Irma Arizola. All Council Members were in favor so motion carried.
- 4. Open Forum: A. Individuals and Committees limited to three (3) minutes. There were no citizen comments.
- 5. Reports. City Manager's Report. The City Manager Velma Davila was not present due to the fact that she was ill. The City Consultant Ashley Eddington was present and ready to discuss the City Manager's Report. The items of discussion were Payroll reports and Bank Balances for the past couple of months. Mr. Eddington also discussed the City Of Encinal Revenue and expenditures by Class. The Members of Council were asked to review the reports and Mr.

- Eddington asked them if they had any questions on the reports. Mayor Sanchez asked Members of Council if they had any questions concerning the reports and the reply was no. Mayor Sanchez announced that Council Member Frank Weikel had walked into the meeting at 5:06 p.m.
- 6. Discussion of Financial Report provided by the City Consultant (presented by City Manager). This item was discussed during item 5.
- 7. Discussion and action to hire CPA Jorge Flores to perform audit's for Fiscal Year 2010 & 2011. Mayor Sanchez explained to members of Council the need to hire Mr. Jorge Flores to do our audits for the 2010 and 2011 years, because there is a need for them for any grant monies the City is applying for. As of this time the Front Street Project must have a current audit as part of the agreement to go forward with the project. An Audit conducted by Mr. Flores would include examining the evidence supporting the amounts and disclosures in the Financial Statements. The Audit would also include and understanding of the Entity and its environments including internal controls. Mayor Sanchez went on to explain that Jorge has done our previous audits. After further discussion there was a motion made by City Council Member Antonio Nieto to go ahead and hire Jorge Flores to conduct the audit, and a second motion was made by Council Member Frank Weikel. All were in favor so motion carried.
- 8. Discussion of Chief of Police status and possible action. (Possible Closed Session Pursuant to Texas Government code, Section 551.071). There was a motion on this item to go into Executive (Closed) Session. The first motion was made by Council Member Frank Weikel and a second motion was made by Council Member

Irma Arizola. The Executive Session started at 5:10 p.m. Council reconvened at 5:28 p.m., at this time Council decided to table any action on this item for a later time. The motion to table the item was made by Council Member Rosa Rivera and a second motion was made by Frank Weikel.

Mr. Ruiz from Ruiz & Associates was present and started off by saying that we need to get to the source of things. Mr. Ruiz spoke about this item for the first time when he first met Mayor Sanchez back in 2009 when he was recommended to the City by Joe de Ochoa from the USDA. Mr. Ruiz went on to say that the City of Encinal was incorporated back in 1978. Mr. Ruiz explained to the members of Council how important it is for the City of Encinal to be platted, so that the City could have control of the Right of Ways. Mr. Ruiz went on to say that the lack of action that has been taken on this matter, tells him that the Land Reform Project has been placed at the very bottom of the City's payment obligations list. After further discussion by the Council they decided that they would continue to pay Mr. Ruiz & Associates the sum of \$5,000.00 every month. There was no need to make a motion for this item because there had already been an agreement to make these monthly payments to Mr. Ruiz.

- 1. Call to order by Sylvano Sanchez, Mayor. Establish if there is a quorum present. Meeting called to order by Mayor Sanchez at 5:05 p.m., roll call was taken by Mayor Sanchez at this time and there were three Council Members present: Antonio Nieto, Frank Weikel, and Irma Arizola. After roll call Mayor Sanchez stated that there was in fact a quorum present and that the meeting could proceed. Mayor Sanchez also noted that Council Member Rosa Rivera was absent because her sister was having a surgery.
- 2. Pledge of Allegiance. Pledge of Allegiance was led by Mayor Sanchez and Council Members.
- 3. Consent Agenda. Approval of minutes from meetings held on May 15, 2012 and June 26, 2012. A motion to approve the minutes was made by Council Member Antonio Nieto and he was seconded by Frank Weikel. All Council Members were in favor so motion carried
- 4. Open forum. Individuals and Committees limited to three (3) minutes. There were no comments at this time.
- 5. Reports: City Manager's Report. City Manager Velma Davila asked Council Members if they had received the fund balance report at their last meeting. City Manager Davila told the Council that she and Mayor Sanchez have been talking to Burke & Company about doing a project for a City Park that would have a water park and regular park for families to be able to enjoy. She also mentioned that they were thinking of placing the park at either the property that is owned by the EEDC or the property that the City has on Berry Street. Manager Davila also discussed with the Council that she is currently working on a letter about Alfredo R. Valles, a local citizen that has helped out the City in the past without being compensated for his work. She explained that there are people talking about this so therefore she will enumerate the number of ways that Mr. Valles has helped the City. Manager Davila also mentioned that just recently the City Landfill had been vandalized and that Mr. Valles again had offered to help the City in repairing the damage done to the gate at the City Landfill. Manager Davila explained to Council that the way the City would compensate Mr. Valles for helping mend the Landfill gate would be by trading his services for payment on his sanitation account. There was also some discussion on the Front Street project, Manager Davila was showing Council how much it cost to include drainage and gutters on the former street project that the City

had across town. She mentioned that on the current Front Street Project there were no plans to include the former so she wanted to know if it was possible to pave a longer section of the street, as it stands the current project would be from Encinal Boulevard all the way to the edge of Highway 44. There was some discussion between Council Members and the City Manager about the termination of City Secretary Armando Aguirre, City Manager Velma Davila clarified to the members of Council that the Secretary had not been terminated but that Mr. Aguirre had abandoned his job.

- 6. Item 6 was tabled due to the fact that there was a gentleman that was to be here and he was running late. Council Member Frank Weikel made a motion to table the item and he was seconded by Antonio Nieto. All Council Members were in favor so item was tabled.
- 7. Discussion and approval to accept Resignation letter of Chief Juan Davila. A letter from Chief Davila was read to the Members of Council and the letter states that Chief Davila is requesting 3 months' severance pay, 6 months insurance and for the City of Encinal to keep his Peace Office License on file for 1 year. A motion to accept the resignation was made by Council Member Frank Weikel and he was seconded by Irma Arizola. All Council Members were in favor so motion carried.
- 8. Return to Item 6. Discussion and consider action to retain Capex Consulting, LLC as Project Consultant and Hejl, Lee, and Associates, Incorporated as Project Engineer to assist the City of Encinal for IH35 Project with the following: A. Texas Department of Agriculture Texas Capital Fund Program grant application. B. Texas Department of Transportation Advanced Funding Agreement. C. Economic Development Agency Funding Application. D. Other funding programs to be identified by Capex and Hejl Lee and Associates. "Capex and Hejl Lee acknowledge that payment by the City of Encinal for services rendered will be contingent on the receipt of funding commitments from the various funding sources identified. Mr. Daniel Hejl has worked in Maverick and LaSalle Counties; he is currently working on the Gardendale Project located a few miles from Cotulla. He explained that the Texas Capital Fund is used to create jobs. The IH35 Project would consist of paving approximately .07 miles located on the east side of IH35.City Manager Davila asked Mr. Hejl that one of the conditions of the project would be that the property owners Becca Martinez and Hector Hall that are located at this access road must annex their property to the Encinal City limit before any application is submitted. City Manager Davila asked Mr. Jeff Snowden if the first application would only cover the 10 acres belonging to Becca Martinez and not the property belonging to Hector Hall and if so how would this benefit the City. Mr. Jeff Snowden stated that this project would fund the access road and provide water lines to both properties. Mr. Snowden said that he was here to protect the City's interest. The City Manager stated that the City will not approve any application to be submitted unless both property

owners, Mrs. Martinez and Mr. Hall both agree to the Voluntary Annexation because the City will have to invest some money on this project as well. Council Member Frank Weikel made a motion to approve hiring Jeff Snowden to start the application process for the Texas Capital Fund and he was seconded by Council Member Irma Arizola. Mr. Snowden was approved to administer the application process "only", if any and other changes that arise if the application is approved he is to work closely with the City Manager so that she will be able to keep the Council informed of how the project is doing and any financials will be handled by the City Accountant.

- 1. Call to order by Sylvano Sanchez, Mayor. The meeting was called to order by Mayor Sanchez at 5:05 p.m. Mayor Sanchez did a roll call to determine if there was a quorum present. Present were Council Members Rosa Rivera, Antonio Nieto, and Frank Weikel. Mayor Sanchez mentioned that Council Member Irma Arizola was running late. After roll call Mayor Sanchez determined that there was a quorum so that the meeting could proceed. Council Member Irma Arizola arrived at the meeting at 5:30 p.m. At the opening of the meeting Mayor Sanchez mentioned to the public that he wanted everyone to be aware of the "Rules of Courtesy" for City Council Meetings posted on the agenda.
- 2. *Pledge of Allegiance*. The Pledge of Allegiance was led by Citizen Anselma Aldaco.
- 3. Consent Agenda. Approval of minutes of meeting held on July 17, 2012. City Manager Davila asked Council to table Item 3 because the date was wrong for the Minutes that were to be approved, they should have been for July 11, 2012 not July 17, 2012. A motion to table the item was made by Council Member Antonio Nieto and he was seconded by Rosa Rivera. All were in favor so motion carried.
- 4. Open Forum: A. Individuals and Committees limited to three (3) minutes.

 Mayor Sanchez asked the public if there were any comments. Council

 Member Rosa Rivera wanted to say Thank You to the Mayor for sending

 Mr. Aldaco to mow the grass at the Villa de Reposo Apartments. Mrs.

 Rivera said that Mr. Aldaco had done a great job. She also mentioned that she was happy to see that there were more Stop signs around town.
- **5.** Reports. City Manager Report. **A.** City Manager Davila wanted to advise Council on a system available to the Police Department called Cop Sync. She stated that this system cost \$19,190.00 but it would be paid over a 4

year period, with the first year payments at about \$667.00 dollars a month. This program would let officers print out tickets, it would let them have a camera to record all their stops, and it would even be able to connect with the Hill Country software that is in use by the Municipal Court. This software could be transferred in between units. The City Manager also mentioned that the Police Department also has some laptops that they can use that they had gotten from the LESO program. B. City Manager Davila also spoke about getting a visit from two gentlemen from Lewis Energy. She was able to meet with Robert Hunter and Mark Marlowe and they said that they wanted to offer the City their assistance with getting our Police units running, they would be willing to let the mechanics from Lewis Energy to check our units and fix things that were needed on them and that they would provide this service to the City without charge. Manager Davila also mentioned that they had even offered to check our Sanitation truck as well. C. Manager Davila said that there are plans to hold a School Supply Drive to help the students going back to school. She said this project would be a joint venture with the Encinal Water Supply Corporation. EWSC has agreed to donate \$250.00 to the City to help buy the supplies. She mentioned that the City Clerk and the girls from the EWSC would get together to see what day they could go buy the school supplies. Mayor Sanchez asked if there was a School Supply list available, City Clerk answered that they would get the list when they kids registered next week. Council member Frank Weikel asked if we knew how many kids the school would have this year and Manager Davila answered that Principal Debra Weikel had said that they would have about 158 students enrolled this school year. D. City Manager Davila said that the Code Compliance budget had been approved with Mario Chavez from MRGC. She said that one of the first things they would like to do with this grant is to install a camera at the landfill to find out who has been dumping trash illegally there. Citizen Anselma Aldaco mentioned that she had gotten a prescription bottle belonging to someone illegally dumping there. Manager Davila praised the Sanitation workers for doing an a great job picking up brush and leaves from around town. Manager Davila also mentioned that Mr. Aldaco had cleaned a resident's property because

there was a concern with all the brush that was located at her lot and that the homeowner couldn't afford to pay to have it cleaned up. E. City Manager Davila mentioned that the City had a meeting with our Texas Senator Judith Zaffirini who stopped by the City Hall on Monday July 30, 2012 to talk with the Mayor and those present that day. Senator Zaffirini discussed the issues that they City is currently having concerning the Platting of the City; overall it was a good and informative meeting. F. The City Consultant Ashley Eddington discussed with Council that the Budget process has begun and that there will have to be two Budget workshops in August to begin preparing for our Budget in September. He stated that there will be two meetings in August to prepare a Preliminary Budget for Public viewing and for any citizen suggestions and then there will be a public hearing in September to approve the final Budget. G. City Manager Davila said she wanted to mention that there had been a letter sent to customers a couple of months ago regarding Ordinance 03-07-005 Nuisance Ordinance, this Ordinance was sent to several Property Owners in Encinal including Greg Springer. City Attorney Juan Caballero stated that Greg Springer's lawyer had made a Public Records request concerning the Ordinance and Caballero said that City Manager Davila had put together the documents that were needed and he went ahead and forwarded them to the attorney.

- 6. Discussion and action to amend CDBG Front Street improvement project contract. City Manager Davila stated that they had a conference call regarding the contract to pave Front Street and to see if it could be amended to include curbs and gutters. Manager Davila said that Ms. Bustamante from Middle Rio Grande advised against this because the City could lose the Contract if it was amended. Frank Weikel made a motion to table the item and he was seconded by Antonio Nieto. All were in favor of tabling the item so motion carried.
- 7. Discussion and Action to approve City of Encinal employee's Personnel Policies for all departments. City Manager Davila mentioned that some issues have come up regarding certain employees that don't want to take orders from the City Manager. Manager Davila stated that she wants the

best for the City and believes that it is important to implement the Policies and Procedures to include everyone that works for the City and the Police Department as well. Council Member Frank Weikel said he wanted to make sure that all employees understand the policy and what it means. Frank Weikel acknowledged the presence of County Commissioner Richard Garza present at the meeting. A motion to approve the implementation of the Policy was made by Frank Weikel and he was seconded by Rosa Rivera. All were in favor so motion carried.

Mayor Sanchez asked Council if they would like to accept the request at this time and Frank Weikel made a motion to accept the request and he was seconded by Antonio Nieto. - 1. Call to Order by Sylvano Sanchez, Mayor and let the record show that a quorum of City Council Members are present, that this meeting has been duly called, and that notice of this meeting has been posted in accordance with the Texas Open Meetings Act, Texas Government Code Chapter 551: After Roll Call it was determined that there was a quorum established. Council Members present were Antonio Nieto, Rosa Rivera and Irma Arizola. Mayor Sanchez mentioned that Mr. Frank Weikel was absent because he had a doctor's appointment in Corpus Christi.
- 2. Pledge of Allegiance: Pledge of Allegiance was led by Judge Hector Cortez.
- 3. Consent Agenda. Approval of minutes of meeting held on August 8, 2012: A motion to approve the minutes was made by Antonio Nieto and he was seconded by Rosa Rivera, all were in favor of the motion so motion carried.
- 4. Open Forum. Individuals and Committee limited to Three (3) minutes: Citizen Alicia Dominguez stated that she wanted to know what was being done about the trucks at the Love's. She mentioned that she had almost been run over by one of these Semis's and she stated that "No cops" showed up. Manager Davila asked if she had called the City Hall. Citizen Dominguez stated that her friend had called 911 and that nobody came to the scene. Citizen Dominguez said that her car's front end was all messed up. Citizen Dominga Martinez stated that she was with Ms. Dominguez at the time and that a Border Patrol had shown up when they called 911. Manager Davila explained to the Citizen that there is always an officer on duty but that it is not their job to be traffic control officer for Love's. Officer Gaytan told the Citizens that he had spoken to the manager at Love's about the need for traffic control for the Love's and the manager told him that it wasn't necessary and that he said that the truckers communicate through their radios and help each other that way. City Manager Davila stated that

TX Dot had been contacted about the issue at the Love's and that there had been a study conducted by TX Dot and they concluded that they could not place a light there at that 4 way stop. Citizen Jennifer Almendariz presented an ordinance dealing with the leash laws to Council. She explained that she had given it to Chief Ibarra to examine and wanted to know if it was a good idea. Manager Davila told the citizen that there was an ordinance for this problem and that the officers were in fact enforcing it. Citizen Almendariz said that her proposed ordinance would be for dangerous dogs and or dogs that chase you and adding restrictions to owners who don't comply with these. Citizen Almendariz stated that she would like to get this proposed ordinance added to the agenda and City Manager Davila replied that they would put it on the next meeting's agenda. Citizen Javier Mancha stated that he had spoken with veterinarian Leyendecker and that she told him that the pound or animal shelter in Laredo had been shut down and that the City of Laredo is currently in the process of opening their own shelter. City Manager Davila replied to Citizen Mancha by telling him that she has spoken to the City of Laredo about helping with the dog problem in Encinal but that they have very limited space so they can't help Encinal. Citizen Christina Maldonado asked Manager Davila if they have spoken to the people in Cotulla. Manager Davila said that she has tried to get help from the surrounding areas to no avail. Manager Davila stated that the City does have an ordinance for the Leash Law, Citizen Almendariz said that her proposed ordinance was better because it would go beyond that and make a dog that chases you a dangerous dog and the owner would have to keep the dog confined and it would mean that the Police Officers would be the animal control authority. Citizen Almendariz stated that she had submitted the Ordinance to Chief Ibarra and was waiting to hear back from him on this matter. Manager Davila told Citizen Almendariz that she would read her proposed ordinance and she would put her on the agenda for the next meeting.

5. Reports. City Manager's Reports: City Manager Davila told Council that she had written Armando Garza a letter of appreciation for letting the City dispose of branches at his property. City Manager Davila shared copies of

- the Food Banks shipping list with Council and citizens because she received a complaint from a Citizen who told her that not all items received from the food bank were distributed to the Citizens. Manager Davila stated that she had given the order not to hand out items if not all Citizens were going to get the item. Manager Davila said that the County does the food distribution differently; they do a first come first serve approach. Manager Davila said that she had the officers and Judge Cortez verify the items that were not given out and they were left inside the City Hall.
- 6. Discussion and Action for hiring Maintenance Person for Sanitation Department: City Manager Davila asked Council if they could table this item because the City has purchased a Sanitation truck and she needs to find out if the person who drives this truck must have a CDL. Citizen Christina Maldonado stated that he was an animal control officer in Cotulla, and if the City could help make new kennels and work together for the safety of the citizens and kids. A motion to table the item was made by Antonio Nieto and he was seconded by Rosa Rivera.
- 7. Discussion on assessment requested by EEDC to hire Crane Engineering: President Javier Mancha from the EEDC told Council that this assessment is need for the infrastructure of the community of Encinal it would help not only the water, sewer but also the ETJs. Once that assessment is done, the City, the Water Corporation and the County should be able to go after other funding. This should have been done like 6 or 7 years ago, I think we should move ahead and do it ourselves. Once the assessment is done an engineer seal is placed on it and we can use it for things like the Mechanical Plant that the Water Corporation needs and the fire suppression system that is required by the State. Mancha stated that Crane Engineering has worked with the City in the past. Mayor Sanchez said that at the EWSC meeting the night before there had been a discussion of doing an assessment for the water corporation, Council Member Nieto stated that they had in fact gotten confirmation that there would be an assessment done after they finish with the current project. City Manager Davila said that she had spoken to Council Member Frank Weikel and that Mr. Weikel was in favor of the assessment, because it would not only help the Water

Corporation but the street improvements as well. Manager Davila suggested to Mr. Mancha that he set up a presentation for the Council by Crane Engineering so that they could make a decision based on that. Discussion regarding any monetary donation for Hecho en Encinal by the City: Manager Davila stated that Mr. Weikel had mentioned something about the EEDC donating \$7500.00 to Hecho en Encinal or something to that effect. Mayor Sanchez questioned Mr. Mancha about a sign that the City had donated money for and it has yet to be placed. Mr. Mancha said that the money was given to Alexander Memorial Library and they were supposed to put up the sign. Mr. Mancha said he spoke to Janet Kreuger and that she was going to ask CJ who works at Alexander Memorial about the sign. Mr. Mancha stated that they were also trying to do an ADA ramp but they were waiting on a donation from Lewis Energy and they have some funding but not all of it. Hecho en Encinal was requesting \$15,000.00 from the City and half of it would be paid by the EEDC and it was agreed that each party would donate \$7500.00, but it was only a verbal agreement there had never been an actual vote on it. City Manager Davila stated that the City was going to pay for everything? Mr. Mancha stated that Hecho was a good non-profit organization for the community because they have a library, they have computers for public use, they help the Girl Scout troops,

- and the Ladies Auxiliary. Manager Davila asked Mr. Mancha if it was possible for somebody from Hecho to come to one of the meetings and explain to the Council what services are being provided by them to the City. A motion to table the item for further discussion was made by Antonio Nieto and he was seconded by Rosa Rivera, all were in favor so motion carried.
- 9. - Call to order by Sylvano Sanchez, Mayor and let the record show that a quorum of City Council Members are present, that this meeting has been duly called, and that notice of this meeting has been posted in accordance with the Texas Open Meetings Act, Texas Government Code Chapter 551. After Roll Call Mayor Sanchez stated that all members of Council were present so there was a quorum present.
- 2. Pledge of Allegiance. The Pledge of Allegiance was led by Council Member Frank Weikel.
- 3. Consent Agenda A. Approval of minutes of meeting held on September 20, 2012. Mayor Sanchez asked Council members that he would like to move up Item number 10 on the agenda, the discussion of Voluntary Annexation of remaining 331.281 acres of Beckalar, Inc. A motion to move up item 10 was made by Frank Weikel and he was seconded on the motion by Antonio Nieto. Mayor Sanchez stated that Mr. Marc Shaw was going to do a presentation on behalf of Bekalar, Inc. regarding the annexation of the remaining 331.281 acres. City Manager Velma Davila stated that she would like to present Marc Shaw with a letter of support from the City. Marc Shaw stated that he represents Becca Martinez, and he has been studying that land for the past 5 months, we have come to the conclusion that we are going to develop that property. Mr. Shaw stated that they wanted the City to annex the property so that it could become a revenue stream for the City; we are here to join you and become a part of the City. I have worked very closely with the Mayor. Mr. Shaw stated that his function in the organization was as Capital Formations Strategist, he's the guy that has to find the money to do everything. Mr. Shaw stated that he has researched North Dakota and the mistakes that were made there; he stated that the Eagle Ford Shale is fairly new and that he wants to make sure those same mistakes are not made here in Encinal. Mr. Shaw state that their intention was to build rock solid housing on this property that would be new and affordable. Mr. Shaw stated that the development around the property would be Commercial investments. The intention is to build apartments, townhomes and single family dwellings, and an RV park. They would also like to place an industrial park on this property that would produce Lexicon Powerblock. This industrial park would be the first in the United States to manufacture this product. Mr. Shaw stated that he would also like to place and excavation site on the industrial park. Mr. Shaw said that the first houses set up in the area would be manufactured homes made by Clayton, the same ones that make the Palm Harbor Homes. Mr. Shaw stated that all the homes would be pre-leased. Mr. Shaw thanked the Mayor and the City Manager for helping him push this project forward. Mr. Shaw mentioned that he saw the construction of a sewer line by the Love's truck stop and he said he didn't have anything to do with that that was done before he got involved. Citizen Glen Beal asked Mr. Shaw if he was going to develop all this land why didn't they develop a sewer

system that would be up to state standards. Mr. Shaw answered that he would like to have the opportunity to build a sewer system if he was allowed to bid on that project. Citizen Glen Beal stated that Encinal has a reputation for always getting ripped off. Mr. Shaw told Mayor Sanchez that he would like to present him with a Signed letter from Becca Martinez for the annexation of her property. City Manager Davila stated that Mr. Shaw would be attending the Encinal Water Supply Corporations meeting on October 17th, and Mr. Shaw stated that he would not be able to make it to the board meeting but that Becca Martinez would be present at it. Mario Chavez form Middle Rio Grande stated that he thought it was important to have a good infrastructure for the type of project that is being built. Citizen Beal asked about the new housing project that Lewis Energy is undertaking and how that would impact the new development across town. Mr. Shaw mentioned that Becca Martinez was willing to donate 2 to 3 acres of land to the Encinal Cemetery Association as long as anybody that was a resident of Encinal could be buried there regardless if they had the money to buy a plot or not. Citizen Nell Kennedy asked Mr. Shaw if these apartments were going to have their own private security and Mr. Shaw answered that yes the development he is working on will have security. City Manager Davila stated that with the addition of Ms. Martinez 331 acres the City of Encinal would now total 700 acres. City Attorney Juan Caballero said that we need the annexation so that the City could keep growing and that the land we annex be developed. Mayor Sanchez thanked Mark Shaw for a great presentation. Mayor Sanchez asked Council for a motion to return to item(3) A motion to return to item 3 was made by Frank Weikel and he was seconded by Rosa Rivera. After reviewing the minutes from September 20, 2012 a motion to approve them was made by Rosa Rivera and she was seconded by Irma Arizola.

- 4. **Open Forum: A. Individuals and Committees limited to Three (3) minutes.** During this time Mayor Sanchez wanted the public to know that he had spoken to the CSA director Robert Diaz about the situation at the Villa de Reposo and the problems they are having there with all the guys getting drunk and partying. City Manager Davila said that the Police department has increased patrol in the area and hopes that will hinder some of the behavior.
- 5. Reports: City Manager's Reports. City Manager Davila stated that they had a pre bid conference for the Front Street Project; Friday will be the opening and awarding of the Bids. She also mentioned that the bidders have 90 days to complete the project. City Manager Davila wanted to recognize the efforts of Citizens Mr. & Mrs. Jose Gonzalez that reside at Rancho Encinal for their generosity in donating supplies for the Children's Halloween Party that will be held at the City Hall. City Manager Davila submitted the monthly Bills to Council for their review. Mayor Sanchez addressed Council and told them that he knew that they had some questions regarding the former Chief Juan Davila's presence with the Police Department and he wanted to clarify to them that Juan Davila was not re-hired but that he was working his reserve hours that are required by TCLOSE. City Manager added that all Reserve Police Officers are required to work a certain amount of hours a month in order to keep their Peace Officer's License active. City Manager Davila wanted to reassure Council that Juan Davila is not getting paid by the City and that the City is not providing him with fuel for his personal vehicle. Council Member Weikel asked Ms. Davila how long was Davila's contract for and she replied that Council had approved a one year contract for former Chief Davila to keep his Peace Officer's License active and that

would be until July 2013. City Manager Davila stated that Juan Davila is a Certified Peace Officer. Council Member Frank Weikel asked Ms. Davila if former Chief Davila could put in his reserve hours somewhere else. Council Member Weikel asked that since the former Chief had moved to San Antonio couldn't he do his reserve hours over there, City Manager Davila replied that he couldn't do his reserve hours somewhere else. Council Member Frank Weikel made a comment that former Chief Davila had been let go because he had gotten a DWI and Mayor Sanchez told Mr. Weikel that those charges against Chief Davila were dropped and City Manager Davila confirmed the Mayor's comments adding that Chief Davila was going to have his record expunged. City Attorney Juan Caballero told Council that he would contact the District Attorney's Office and would get more information for them. Commissioner Ricardo Garza asked if the City would be liable if the former Chief put in his hours?, and City Manager Davila said no because he is a Reserve Officer with the City Of Encinal and he is not getting paid and all reserve officers must put in their hours or the Police Chief would be in violation with TCLOSE. Council Member Frank Weikel if the new officers being hired are having background checks and City Manager Davila replied that yes all new hires are getting a background check. There was a discussion amongst the public about whether or not Constable Maldonado was a Certified Peace Officer or not. City Manager Davila stated that she had put out an RFQ for the sidewalk along Encinal Boulevard for the safety of the children that walk to and from school. Manager Davila stated that she had posted the RFQ in the newspaper and the bidding would close on the 31st. Citizen Nell Kennedy commented that the signs for "no trucks allowed" in the Berry Street area are gone and City Manager Davila responded that they were aware of the issue and that TX. Dot had been advised of this already. City Manager Davila stated that the new Sanitation Truck is currently in operation and the new pick up schedule is Mondays and Thursdays for businesses and residents. City Manager Davila stated that the City has received a truck from Chesapeake Energy to be used by the Code Enforcement officers. The City Manager stated that the City of Encinal Police Department is going to start a DARE program at the School which will last for about 8 weeks and they will have a graduation ceremony at the end. City Manager Davila said that Encinal Elementary teacher Marissa Nieto had approached her and was talking to her about having a 5k run sponsored by the Student Council and it would be the first week in November. City Manager spoke about the Maintenance Department always doing the landscaping at the Villa de Reposo and we had never been compensated for it but now the CSA has agreed to pay for the services the Maintenance Department perform there. City Manager Davila spoke about creating a fund for the Villa de Reposo residents from the money that the CSA is paying for the landscaping services, these funds would be available to the residents to help pay for utility bills or for help with the payment of their monthly rent.

6. Presentation from Crane Engineering to City Council regarding Assessment for the City of Encinal. Eddie Garza from Crane Engineering told Members of Council that he would like to do a study of Encinal's infrastructure; he said he has been working with Encinal and La Salle County since 1999. Mr. Garza mentioned that he had worked with TX Dot on a street improvement project and during this time he also worked on creating and recreating street plats. Mr. Garza spoke about having adequate fire protection for the City by making sure that we had the needed space between fire hydrants as well as the correct size of pipes. Mr. Garza stated that they were

the engineers that had platted Rancho Encinal. Mayor Sanchez asked Mr. Garza is the Rancho Encinal subdivision platted with metes and bounds and officially recorded, Mr. Garza responded that the plats are recorded but they are not by metes and bounds. Mr. Garza stated that there are about 4 different areas within the City of Encinal that need to be replatted. Mayor Sanchez asked Mr. Garza if his platted maps were officially sealed and recorded by the court; Mr. Garza replied that he was not platting land. Council Member Weikel mentioned that the City of Encinal was platted back in 1979 and Mayor Sanchez responded that it was platted to establish City Limits. Mayor Sanchez stated that the City had five years to use Colonia funds to Plat the City but that it was never accomplished. Mayor Sanchez stated that he had visited Mr. Garza's office and had seen a map that they had but the map did not have metes and bounds; Mr. Garza said that his maps were for study and research only not Official platted maps but were being used to construct streets in the City. Mr. Garza stated that he was never retained to plat the City of Encinal. Citizen Glen Beal asked if the City is currently doing anything about the platting issue, and Attorney Caballero responded that the City is working on it but some issues have come up with that project. City Manager Davila stated that currently there are no grants for platting but that we are trying to go around it and apply for a grant for infrastructure which we could use for the Land Reform. City Attorney Caballero mentioned that 3 years ago a Land Reform grant had made it to the Governor's office but that the Governor had refused to sign it at the last minute. There was some discussion as to how you can get a guaranteed deed for property owned here in Encinal and the conclusion was that you would have to get a certified surveyor to plat your property and have him record it for you. Mr. Garza from Crane Engineering spoke about the need to have an assessment to study the need for the existing infrastructure and the needs for water, sewer, streets and drainage. City Manager Davila stressed that this study is for infrastructure and any information gathered for the Encinal Water Supply Corporation will be shared with them but the Corporation is an entity of itself and the City cannot speak for them. Mr. Garza submitted a Contract to the Council.

- 7. Discussion and Action on Assessment requested by EEDC to hire Crane Engineering. City Attorney Caballero suggested that before we accept the contract he would like to consult with Council and Mr. Mancha and so that he could have a chance to take a look at some of the items on the Contract. EEDC President Javier Mancha stated that the EEDC has already approved it and now it would be up to the City. City Manager Davila stated that the Study could be approved by Council but that they would like City Attorney Caballero to take a look at the Contract before it would be signed and approved. Council Member Frank Weikel made a motion to let the City Attorney review the Contract before the City would sign it; he was seconded on his motion by Councilman Antonio Nieto. City Manager clarified that Council had approved the assessment but that the Contract would be reviewed by the City Attorney before it could be signed and approved.
- 8. Presentation from Hecho en Encinal on the organization & projects funded by City of Encinal & EEDC. EEDC President Mancha stated that Janet Kreuger apologized for not being able to attend, but that she would make time for the next scheduled Council meeting. Mancha wanted to update Council on the proposed sign that Hecho was supposed to place with funding from the City and EEDC and he said that they were still waiting on some negotiations from Lewis Energy.

- City Manager Davila mentioned that if it would be possible to get the County involved in donating money to the Hecho en Encinal Program. Mancha stated that he wanted it to be clear that the money donated to Hecho was not being used for Payroll, but to refurbishing the building itself. Council Man Frank Weikel made a motion to table the item and he was seconded by Councilwoman Rosa Rivera, all were in favor so motion carried.
- 9. Discussion of 1st reading of Ordinance No. 2012-0926 regarding Building, Mechanical, Plumbing & Electrical Permit Fee's. City Manager Davila explained to the public that these are International ICC codes that are used for plumbing, building and electricity that are needed for the new infrastructure. Attorney Juan Caballero suggested that Council Members review the ordinances since this was the first reading. City Manager Davila stated that The City Inspector will be Mr. Salinas from Laredo and he will be a Contractor meaning that the City will not have to pay him a salary but from the money collected from the permit fees.
- 10. Item 11. Discussion and Action on letter to Encinal Water Supply regarding Lift Station on East Side of IH35. There was some discussion about the need for a Lift Station on Highway 44 and Mayor Sanchez stated that there are 2 businesses located there that needed this. City Manager Davila spoke about the possible development of a 100 room hotel located off Highway 44. EEDC President Javier Mancha stated that the lift station would benefit the existing businesses as well as help the City collect Ad Valorem taxes since this area will be annexed to the City. City Manager Davila stated that the City could apply for a Texas Capital Fund loan to help the EWSC for the Lift Station on the East Side of IH 35. Irma Arizola made a motion to have the City Attorney draft a letter to the EWSC requesting the Lift Station and he was seconded by Frank Weikel.
- 11. Item 12. Discussion and Action on Adopting Dangerous Dog Law for the City of Encinal. City Attorney Juan Caballero stated that this was the first reading of this ordinance and that this ordinance is repealing a previous ordinance and that he had modeled this ordinance from the City of Laredo. City Attorney Caballero stated that this ordinance would not only address the dog problem but other animals as well, he noted that there have been concerns about horses roaming loose. Attorney Caballero stated that this ordinance is repealing and replacing Ordinance 4-5-93. City Manager Davila stated that there was some concern regarding the keeping of 4-H animals within the city limits and she mentioned that this was something that was very common in her hometown because there were a lot of kids that have projects like this as well. Citizen Nell Kennedy asked what is being done about the dogs. City Manager Davila stated that the officers were giving out citations and they are also trying to address the loose animals in town. City Manager Davila stated that they have not been successful in getting any help from animal control anywhere. Mayor Sanchez addressed County Commissioner Garza and asked him that he had been told by County Judge Rodriguez that he would help the City build something for the city and he would like to have a reply from him. Commissioner Garza replied that he would be glad to bring this issue up before Commissioner's Court.
- 12. Item 13. Presentation and Action from EEDC President for new Business Signs. EEDC Board Member mentioned that he would like to help new and existing business with infrastructure by helping them with new signs for their businesses and help beautify Main Street as well. Mancha stated that there would be a cap of \$12,000 for the spending for the year. City Manager Davila

- stated that there would be an application for local business owners so that they could apply for this grant being offered by EEDC.
- 13. Item 14. Discussion on request by County Commissioner Garza on Light fixture on Carr St. /Encinal Blvd. City Manager Davila stated that this item had to be brought before Council because light poles installed by AEP cost the City \$1600. City Manager Davila presented Commissioner Garza with a list of all street lights located on County property. City Manager Davila stated that the City pays AEP \$1700.00 every month for these light fixtures. City Manager Davila stated that we could possibly speak with Mark Ochoa the engineer for AEP and see what can be done about this.
- 14. **Item 15. Adjournment.** A motion to adjourn the meeting was made by Council Member Antonio Nieto and he was seconded by Frank Weikel.

Call to order by Sylvano Sanchez, Mayor and let the record show that a quorum of City Council members are present, that this meeting has been duly called, and that notice of this meeting has been posted in accordance with the Texas Open Meetings Act, Texas Government Code Chapter 551. Meeting was called to Order by Mayor Sanchez at 10:03 a.m. present were Council Members Weikel, Nieto, and Rivera. Mayor Sanchez stated that Council woman Arizola was absent because she was at work. Mayor Sanchez stated that there was a quorum.
- 2. **Pledge of Allegiance.** The Pledge of Allegiance was led by Councilman Frank Weikel.
- 3. Consent Agenda. A. approval of minutes of meeting held on October 9, 2012. A motion to approve the minutes was made by Frank Weikel and a he was seconded by Council woman Rosa Rivera, all were in favor so motion carried.
- 4. Open Forum: A. Individuals and Committees limited to Three (3) minutes.

 Citizen Anselma Aldaco commented that she hadn't been at the previous meeting but that her name was mentioned on the Crane Engineering Contract; she asked Council Member Weikel and Javier Mancha why they hadn't put their names on there? Aldaco stated that she was the Chair Person but why hadn't they put their names on there, she stated that she wasn't here at that meeting and that she was not all for that (Contract).  asked her if she had proof it was contaminated? Mr. Cassiano stated
 that he had proof it was not contaminated. Ms. Dawson asked him if he
 had a TCEQ permit and he answered no. There was some clarification
 made as to why the City had not purchased the James Mercantile
 building in the past but it was not because it was contaminated, it was
 because federal grants don't allow you to purchase property that


contain underground storage tanks stated City Manager Davila. There were words being exchanged back and forth and City Attorney Juan Caballero suggested that both sides state their positions and then we can meet in closed session. Ms. Dawson stated that she just wanted to stop the demolition of the building and that she had her attorney file a temporary injunction. City Attorney wanted to clarify if Ms. Dawson's attorney was filing the injunction in La Salle County and Ms. Dawson answered yes. Mr. Cassiano started by saying that she (Ms. Dawson) didn't have proof about anything she was stating. Mr. Cassiano stated that an engineer had conducted a study of the property and that soil samples were taken as well to check if there were any asbestos present and none were found on the property. Mr. Cassiano stated that he filed a form with Austin to demolish the property, he also stated that her (Ms. Dawson) claim that it was a historical site were not true. Mr. Cassiano stated that the building was hazardous and there have been thefts there as well, the roof is falling down, and the walls are cracked. Mr. Cassiano stated that he was concerned that if the roof fell it could hurt somebody and he would be liable for it. City Attorney Caballero asked Mr. Cassiano if he had a purchaser for the building. Mr. Cassiano responded that no he didn't. Mr. Cassiano went on to state that this property had been for sell and there were people interested in it but it all came to nothing, nobody could buy it. Attorney Caballero asked Mr. Cassiano how much he wanted for the land. And he replied that he wanted one hundred and fifty thousand dollars. Attorney Caballero asked Mr. Cassiano if he would be willing to stop further demolition for one day. And he replied that they would not be working today. Mr. Cassiano went on to state that he would have to be convinced that they have the right to stop me. Ms. Dawson stated that the only reason the building was not historical was because it had not been registered. Attorney Caballero stated that he wanted to help both sides come to an agreement. Mr. Cassiano told Ms. Dawson that he would not continue the demolishing of the building at night. Attorney Caballero stated that Council would meet in closed session to determine if any action would

have to be taken. Councilman Weikel stated that he had seen Mr. Cassiano's papers and they are from the state and that there were no hazardous materials. Mr. Weikel wanted to know if we voted for something historical, would that make his house historical because it's more than fifty years old. Attorney Caballero stated that would be discussed during closed session. Ms. Dawson asked for clarification on why the City couldn't purchase this property. City Manager Davila stated that all the tanks would have to be removed. Mayor Sanchez stated that an environmental study had been done on the property. Attorney Caballero went on to clarify that the property was not hazardous and that the City had applied for a loan from USDA and that as long as the tanks were there the City couldn't get the loan. Mayor Sanchez went on to say that if it was a private entity they can do what they want but since it's a City they must follow all state and federal regulations. Council withdrew to Executive session on a motion made by Councilman Frank Weikel and seconded by Irma Arizola. Council returned to open session at 11:22 a.m. Councilman Weikel made a motion to not take any action pending the litigation in this matter he was seconded by Councilwoman Rosa Rivera. Attorney Caballero explained to Ms. Dawson that her lawyer would have to deliver the injunction to the District Judge, and he needs to explain why he needs the injunction, the Judge will either set a bond or not set a bond and decide whether he wants to hold the demolition or not and the injunction would be to keep the status quo until he has a chance to look at it, basically an injunction or restraining order, generally you would have to have a hearing within fourteen days and the Judge can decide whether or not a restraining order should be turned into an injunction. There was some discussion between Ms. Dawson and Mr. Cassiano regarding the demolition of the building in question.

- 1. Call to Order by Sylvano Sanchez, Mayor and let the record show that a quorum of City Council Members are present, that this meeting has been duly called, and that notice of this meeting has been posted in accordance with the Texas Open Meetings Act, Texas Government Code Chapter 551. Council Members present were Frank Weikel, Irma Arizola, Rosa Rivera and Antonio Nieto. After Roll Call, Mayor Sanchez determined that there was in fact a quorum as all Council Members were present.
- 2. Pledge of Allegiance. Pledge of Allegiance was led by Mayor Sanchez and members of Council.
- 3. **Consent Agenda.** A. Approval of minutes of meeting held on November 7, 2012. A motion to approve the minutes as stated was made by Council Member Antonio Nieto and he was seconded by Ms. Rosa Rivera, all were in favor so motion carried.
- 4. Open Forum: A. Individuals and Committees limited to Three (3) minutes. Citizen Dominga Martinez from the Villa de Reposo thanked the Mayor and City Council Members for sending someone to mow the lawn at the apartments and that it looked a lot better, but that it still needed some work. Citizen Anselma Aldaco mentioned that the City had no water at this time, and that there is still some work to be done about the stray dogs in town. The City Manager and members of Council also mentioned the breaking of windows at the new apartments located at Berry Street. City Manager Davila mentioned an incident that had been reported on South Nogalitos Street, she stated that there had been a report filed with the Police Department about a stray bullet at a home in that part of town. Mayor Sanchez mentioned that the house belonged to Georgie Gonzalez. Council Member Antonio Nieto told Council and those present that he had heard gun shots by his house on Bermuda Street and that he had also found a dead bird on his own backyard.
- 5. Reports: EEDC report, City Managers Report, Accountant Report. City Manager Davila said that there would be no EEDC report at this time because there was some confusion as to the date they were going to have the EEDC meeting. City Manager Davila stated that she had gotten a new CPL light Contract because the City had been having very high light bills the last couple of months. She stated that she called CPL and told them that she was going to change providers because the bills lately had been very high. She went on to say that when she contacted CPL they informed her that the reason that the bill has been very high is because the City had not set up a contract with them and now the City would be getting a much better rate. City Manager Davila told Members of Council that the City had purchased a new Time Clock for the employees. Manager Davila wanted Council to know that our State Representative Ryan Guillen had set up a conference call with TX Dot regarding the Access Road project. She went on to say that Representative Guillen was working hard to help us get funding from TX Dot for this project that the City is working on. City Manager Davila stated that on Monday, December 17 we would

be handing out gifts to the elderly and stockings to the toddlers in the City. Manager Davila stated that on December 21 we would be distributing gifts to all the 159 Encinal Elementary students, she said that anybody who would like to join us, that they would be welcome. City Manager Davila went on to say that on December 20th we would be having our monthly Food Bank and that this time we were going to have pork, beef, turkey, and chicken, and of course all the regular things that we order from the Food Bank every month. Manager Davila told Council that we would be having the employees Christmas Party on the 20th as well; the party will be from 6 to 8 pm. City Manager Davila announced that Rosa Rivera our Council woman will be resigning from City Council because she will be leaving the City of Encinal. Manager Davila read a letter from Councilwoman Rivera regarding her departure and Ms. Rivera's well wishes for the City in the future. City Manager Davila mentioned the annexations that were done in August and October will be on the tax rolls this coming year 2013. City Manager Davila presented Council with the monthly bills for their approval and she said that she was only lacking the EEDC which should be about \$9,000.00. City Manager Davila said that she had a conference call with Erica Bustamante from Middle Rio Grande regarding the Front Street Paving Project and a bill that the City received for \$5,000 from Geo Tech and that Engineer Seca had charged the City for writing a check to Geo Tech in the amount of \$3,000 so Erica will try to get 3 different bids for Geo Tech and once we finish with that we can start with the bids because he is going to give new specs. City Accountant Ashley Eddington has a Budget to Actual Report for the Council. Mr. Eddington discussed the large amount of property taxes that were deposited and some of the amounts were being kept in reserve, Mr. Eddington also mentioned that the Municipality had gone over their budget amount for the month and that the same thing could be said about the Salaries for the month. Councilman Frank Weikel asked Mr. Eddington if we were still in the "black" and Mr. Eddington replied yes we were.

- 6. **Discussion and Approval on Budget Re-allocation submissions.** Mr. Eddington stated that he did not have any Re-allocation submissions at this time, that there had been some discussion as to some software for the Police department. Manager Davila said that the software for the Police Department would be for the officers and they would have be able to print the tickets from the computer, she said that this software also has a GPS tracking device for the unit if the officers would be in trouble they could be tracked like this. No action on item.
- 7. Discussion and Approval on Resolution regarding Federal Disaster Mitigation Act of 2000 and FEMA. Mayor Sanchez stated that this was a resolution that had to be passed to be able to receive aid from FEMA if a disaster were to happen. We would qualify for federal funds in the event of a disaster. A motion to approve the resolution was made by Councilman Frank Weikel and he was seconded by Antonio Nieto, all were in favor so motion carried.
- 8. Discussion to approve the presentation to the EWSC from City Consultant Mr. Ashley Eddington regarding Mechanical plant. Mr. Eddington asked to be placed on the EWSC agenda to discuss the possibility of entering into a joint venture with the Water Supply Corporation regarding the building of a Mechanical plant. The City and the EWSC would apply for a Texas Capital Grant Fund together and this would benefit all the Citizens of Encinal. The Texas Capital Grant Funds is a grant that the Water Supply would not have to pay it back if it's approved. Mr. Eddington stated that there are a lot of Investors interested in coming to the City but that if our

water and sewer capacity can't meet their demands then they can't come into this City. There was a comment made by a Citizen of merging the Water to the City and Manager Davila responded that is not what the City wants, we would like to work with the Water Corporation on this issue. Mayor Sanchez asked Mr. Eddington about the job creation contingency and Mr. Eddington responded that for every \$25,000 funded you would have to create jobs, not necessarily at the mechanical plant, but in the city. Mr. Javier Mancha from the EEDC mentioned that there were some new businesses coming into town and that one of their first question was about the City's infrastructure. Mr. Mancha said that one of the businesses was a hotel and that the other was a Car Wash. Mr. Eddington also mentioned the possibility of the waste water being sold for either irrigation or fracking. A motion to approve the presentation of Mr. Eddington to the EWSC was made by Councilman Frank Weikel and he was seconded by Councilwoman Irma Arizola.

- 9. Discussion and Action on Christmas gifts for employees. Manager Davila suggested giving the employees a check and she said that it would be for the Police Officers, the Sanitation workers and the Municipal Clerk; Ms. Davila would not be included in this. Mayor Sanchez asked Council how much they would like to give the employees. Councilman Antonio Nieto suggested that the employees be given \$100. A motion to approve the \$100 gift checks was made by Councilman Antonio Nieto and he was seconded by Frank Weikel, all were in favor so motion carried.
