RESOLUTION TO AUTHORIZE AND ADOPT LOWER PROPERTY TAX RATE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017-2018 FOR THE CITY OF ENCINAL, TEXAS

WHEREAS, the City Council of the City of Encinal has determined that is feasible to lower the current take rate for the fiscal year 2017 - 2018 fiscal to .00679100 (.679100/100); and

WHEREAS, the City of Encinal, LaSalle County, Texas approved the lower tax rate of .00679100 (.679100/100) during the August 24, 2017 City Council meeting.




Dear Mr. Sanchez,

The Cotulla ISD is currently planning for the process of printing and sending tax notices for the coming year. We are requesting that you provide us with the approved tax rate for the tax notices that will go out before the end of September. It would really help if we could have the rate, broken down by M&O and I&S, by the fifteenth of September, 2017. This would allow us time to perform the necessary steps for processing and give us a little lee-way should a problem arise.

I know that this is early for the City to approve its tax rate, but if the benefit of early payment is going to be awarded for the payment of school taxes beginning in October, we need your rate by the specified time. Failure to receive the rate may result in a separate run for the taxpayers of the City and the cost will be accrued to the City.
