Call to order by Sylvano Sanchez, Mayor and let the record show that a quorum of City Council Members are present, that this meeting has been duly called, and that notice of this meeting has been posted in accordance with the Texas Open Meetings Act, Texas Government Code Chapter 551. Meeting started at 5:01 p.m.

- 1. Pledge of Allegiance. The Pledge of Allegiance was led by Mayor Sanchez and the City Council.
- 2. Approval of minutes for Regular Meeting on December 11, 2012 & Special meeting December 17, 2012. A motion to approve the Minutes as stated was made by Council Member Frank Weikel and he was seconded by Rosa Rivera. Both sets of minutes were approved as stated all were in favor so motion carried.
- 3. Open Forum: A. Individuals and Committees; B. EEDC Report; C. City Manager's Report. Javier Mancha from the EEDC said he did not have a report for the EEDC but there was something's he would like to cover. Mr. Mancha said that they had completed in December the yearly budget that right now all that the EEDC owes is the \$7500.00 to Hecho en Encinal and they owe the City \$7000.00 as well. Mr. Mancha also mentioned that EEDC would also be helping with the Front Street Project. City Manager Davila stated that she had written a letter to Mr. Love to see if they could donate an additional two lots for the City Hall project located on Berry Street, she let them know that the additional property would house all the City equipment, the Police units, and if there was any space remaining that they would like to build a little park area with picnic tables and barbeque pits. Ms. Davila stated that Mr. Love was going to donate the additional two lots to the City. There were some questions about the Building for the City Hall and they were answered by the City Manager, Council Members, and the Mayor. City Manager Davila mentioned that the new Code Enforcement truck that was donated by Chesapeake Energy has had the Logo installed on it. Captain Gaytan will be the Code Enforcement Officer.
- 4. Approval of Mayor & Council member seats available for the May 11, 2013 General Election. City Manager Davila said that all Council members and the Mayor's seat are up for election this year. Manager Davila stated that Council Member Rosa Rivera may sit in on today's meeting because her replacement has not been sworn in. She went on to state that the Council Members do not get paid to serve, the only one that gets paid is the Mayor and he earns a thousand (\$1,000.00) dollars a month. A motion to approve the Mayor & Council Members seats available for the May 11, 2013 General Election was made by Councilman Frank Weikel and he was seconded by Councilwoman Irma Arizola.

City Manager Davila stated that Judge Cortez would be the Election Judge for the early voting and for the General Election in May; she also mentioned that the Clerk would be Linda Ramirez; the Deputy Clerk would be our Consultant Ashley Eddington. City Manager Davila went on to say that the only ones you would have to set a pay rate for would be the Election Judge and the Clerk. No motion needed on this item because it's the first reading.

- 8. 1st reading on Amendment on Ordinance NO: 2012-10-24-A1 The City of Encinal adoption of the 2012 Edition of the International Building Code. City Manager Davila stated that there had been some problems with an amusement or eight liner business here in town, there was a complaint made against this business. City Attorney Juan Caballero stated that we had to define what an amusement machine is; how to permit the machines, you have to permit it by serial number and each machine will pay a permit fee of one hundred fifty dollars per machine, for a year. Attorney Caballero went on to say that this is the way it's done in other cities, he said that there were questions about banning it at first but that we don't have the authority to do that, that would be up to the County. Caballero went on to say that if the County does not consider them illegal then they would have to meet certain standards to operate in the City, and the first would be the permits and they must abide by them. Caballero also spoke about the patrons bringing alcohol to the facility and drinking till all hours of the morning, thinking they can do this because they are on private property, we have contacted the Texas Alcohol & Beverage Commission and they said they can't do that. Caballero also went on to say that they are not allowed to drink after 12:05 a.m. on weeknights and 1:05 a.m. on weekends. City Manager said that she spoke to the owner about the complaint made against them and he stated that they were not doing any of those things but that the tenant that lived upstairs at the establishment was the one hearing all these things. Caballero said that we are amending the Ordinance to provide for the machines since they are already here and to have them pay their fees and so that they can be within the legal requirements of the City. City Manager Davila spoke about Chick Fil-A being in Encinal from now on every Friday. Manager Davila said that an officer had approached the employees of Chick Fil-A and asked them if they had a Vendor's permit and that they didn't have one so the officer told them that they needed to contact the City Hall. On

- Monday a representative from Chick Fil-A came to the City Hall and took care of their Vendor's permit and they were also contacted on behalf of the City Manager to pay sales tax on the items sold here in Encinal. There was some discussion as to the parking situation where the Chick Fil-A business is located and some of the problems that might arise from it.
- 9. Discussion and Action on Inter-Local agreement between the City of Encinal and La Salle
 County regarding funding for Animal Shelter. City Manager Davila stated that the County would
 be giving the City twenty five thousand dollars to build the Dog Pound here in Encinal. Manager
 Davila went on to say that the Animal Shelter would be located at the City Landfill and that the
 area had to be shaded and with a roof over it, there has to be a minimum of so many cages and
 the money would be used to provide for the cages and animal feed as well. There would be a
 monthly round-up of the dogs and we are only obligated to hold them for three days and then
 they may be euthanized. Manager Davila said there would be an area to hold dogs that have
 rabies. Davila stated that the dogs that would be picked up would be the ones that are not on a
 leash and roaming the streets, dogs that are fenced in or on a leash in their yard will not be
 picked up. A motion to authorize the City Manager to accept the final agreement with the
 County Judge was made by Councilman Frank Weikel and he was seconded by Councilwoman
 Rosa Rivera, all were in favor so motion carried.
- 10. **Discussion and Action on Voluntary Annexation for Norstar Investment Group, Inc.** A motion to table this item was made by Councilman Frank Weikel and he was seconded by Councilwoman Rosa Rivera, all were in favor so motion carried.
- 11. Discussion and Action on entering in Agreement with City of El Cenizo to collect their weekly trash pick-up. City Manager Davila said that she had received a call from County Commissioner Vasquez from the city of El Cenizo asking her if they could help pick up the trash in their City because their sanitation truck wasn't working and she told them that she had to speak to the Mayor first and then she would get back to them. Manager Davila said that the Mayor had said it would be okay and that she had also let the Mayor Pro-Tem Frank Weikel know that they would be helping out El Cenizo for that day. She went on to say that the City of Laredo has helped us in the past in a lot of different ways so she felt it was okay to lend them a hand. Councilman Weikel said that it was good politics on behalf of the City Manager and it was a good deal but we can't help them every week. A motion to deny the agreement was made by Councilman Frank Weikel and he was seconded by Councilwoman Irma Arizola, all were in favor so motion carried.
- 12. Addendum: 1st Reading on RESLOLUTION NO. A01292013 OF THE CITY OF ENCINAL, TEXAS, REQUIRING CERTAIN STANDARDS MUST BE MET FOR QUALIFICATION FOR HOLDING MUNICIPAL OFFICE. City Attorney Caballero said that we believe that the people on the Council and the Mayor, as leaders of the community be setting the example for the rest of the City as far as the payment of the fees for their trash pickup, their water, to be paid up on state and local taxes. Before anyone holds a City office, what it requires is that they be paid up with all their City fees, before they qualify to run for office. Once they are in office they must be up to date with all the fees, they are also required not to be involved in other boards that would have a conflict with the City said Attorney Caballero. Mayor Sanchez said that he would be resigning from the Encinal Water Supply Corporation board. No action needed at this time this is only the

Councilman Antonio Nieto asked if he was at the other board did he have to choose and the answer was yes he had to choose between the Water board and the City, he answered he would resign right now from the Council. Councilman Frank Weikel told Mr. Nieto that he needed to turn in a letter of resignation. A motion to pass the resolution was made by Councilman Frank Weikel and he was seconded by Councilwoman Irma Arizola. Mayor Sanchez stated that Mr. Nieto opposed. Final Reading on Ordinance No. 20130129 establishing a Final Fee for a candidates application for placement on the ballot for City Office, providing severability clause, and providing for an effective date. City Manager Davila said that the officers should be patrolling the whole City; the only time there is no coverage is Sunday and Monday nights. City Manager's Report: City Manager Davila stated that she was going to turn over some Code Enforcement letters to the City Attorney Juan Caballero that were researched by Mrs. Aldaco. The lots were abandoned lots and lots that needed cleaning and Mrs. Aldaco brought the list to Linda and they were typed up and all we are lacking are City Attorney Caballero's signature stated City Manager Davila. City Manager Davila told local citizen Josie Poncedeleon that the letters included the owners of the property next to her house. Citizen Josie Poncedeleon said that there were a lot of bees in that property and that she had been bitten by the bees. City Manager Davila went on to say that the City had received a check for \$16,570.00 from the Middle Rio Grande for the Code Enforcement grant, that's still in the grant account, we haven't dispersed It to different areas yet, because we still have to buy the software and we have used some of the Code Enforcement Officer's hours, but we will disperse it stated City Manager Davila. Consultant Ashley

Eddington said the grant was awarded by Middle Rio Grande, we had the truck donated by Cheasepeake Energy, and so we have the full grant awarded so now we must start the dibursements. Councilman Frank Weikel asked if they had started the disbursements and Mr. Eddington replied that we have some money that has been encumbered but we haven't put it back into the general fund. City Manager Davila said that the City had received \$20,740.00 for the Front Street Project but we had to pay back EEDC \$16,248.52 that was paid to Engineer Hugo Seca and we also made out a check to Middle Rio Grande for \$4,500.00. City Manager Davila said that the City would be celebrating the first annual Cinco de Mayo Celebration on Sunday May 5 at the County Park, we decided that we would like to do something for the City and I did ask some local people for donations and we are going to be having a bingo, cake walk, waterslide and fajita and bean cook-off.

4. Discussion and Action on bid Award for CDB Contract No. 711181. City Attorney Juan B. Caballero told Council that on this item we need to award the bid for the bid held last week, he said he had been on the phone with Middle Rio Grande, reviewed the requests, went over the procedures that were followed and what the bid specifically instructs us to do is that all bids must be turned in by two o'clock on that day, everyone that was here, the City elected to go with the Consultant's time which was on his phone and the last bid was accepted at 1:59, based on that all bids were timely, they were opened, based on the criteria given to us by Middle Rio Grande, based on the Government Code which I'll read to you: "Municipalities are required by State law to award the Contract to the lowest responsible bidder based on certain requirements in the local government code." City Attorney Caballero said that the other option that we have other than awarding it to the lowest bidder is to reject all the awards and put it out for bids again. City Attorney Caballero asked Engineer Hugo Seca if he had reviewed all the paper work so you have confirmed that they were all qualified bidders and did you check their bond requirements? Engineer Seca said that he only had to check the bid bonds that after being awarded a contract the lowest bidder would have to secure the bond; Engineer Seca added that he spoke to the lowest bidder and he would be able to secure the bond if he was awarded the contract. City Manager Davila said that there had been some concerns regarding the Front Street Project and that the City had received a letter from Kevin Smith the Regional Coordinator from Middle Rio Grande addressed to Mayor Sanchez on April 5,2013 the letter stated: "The Texas Department of Agriculture is currently reviewing the existing TxCDBG contracts awarded approximately 18 months ago to determine compliance with the Project Implementation schedule and the Special Conditions as outlined in your contract. According to TDA records your locality may not have satisfied certain provisions of the above referenced contract. TxCDBG Contract No. 71181 is scheduled to expire in less than six months on September 30, 2013. At this

point, eighteen months into the allotted two-year contract period, the Project Implementation Schedule (Exhibit C of the TxCDBG contract) requires 75% completion of the overall project. This message is a courtesy notice that your community has not yet reported compliance with the 75% completion milestone for the referenced TxCDBG project." City Manager Davila went on to say that if we don't meet the requirement that we could lose the grant, she explained to those present that this project had been bid four months ago and this project should have been started a long time ago, because you have 90 days to complete the project and then you have to have at least two months to do the closing instructions. Mr. Glenn Boultinghouse from Core Construction told City Council that he had gotten a call from three Contractors that were present at the Pre-Bid meeting stating that the gentleman from ALC construction was late to the meeting. Mr. Boultinghouse stated that he was not against the Contractor just against the system. Mr. Boultinghouse said that he has worked for the government and County on projects and he was questioning the fact that the time was different than those present at the meeting. City Manager Davila said that the time on Engineer's Seca's phone did say it was 1:59 p.m. Mr. Boultinghouse went on to say that he wanted the bid to be fair to all those involved. City Attorney Caballero said that we were not trying to be unfair or play by different rules but at that point a decision was made that our designee set it, he and Mayor conferred on the time. City Manager Davila said that the designee that day was architect Hugo Seca. Erica Bustamante from Middle Rio Grande usually leads the bids, but she was not here so he was the one leading the bids, we went according to his (Seca) time. It is the City Manager's responsibility to open bids and I did that. Mr. Boultinghouse said that he did not agree with that, that he would like to go on record that he's protesting that decision. City Attorney Caballero stated that the City has elected to accept the lowest bid and the bid will be awarded to ALC Construction, it was a base bid of 234,185.00 Mayor Sanchez stated that he needed a motion for this item. At this time Mr. Boultinghouse asked where Erica was when the bid took place. City Manager said that she opened the bids because Erica wasn't here and they had Mr. Seca present. Mr. Boultinghouse said that there were two mistakes done that day. Councilman Frank Weikel said he wants to move ahead with the project because it's been put off too many times. Councilman Stewart Howard said he disagreed because the timing was wrong and he shouldn't have been let in. Councilman Howard said that he would like a motion to table the item. Councilman Weikel said he motioned to go on or accept the bid. City Attorney Caballero stated that there could not be two motions at the same time. Councilwoman Arizola said that she wanted to second Councilman's Howards motion. City Attorney Caballero explained to Councilwoman Arizola if she wanted to table the motion and bring it back at another time or do you want to reject all bids, then you would have to rephrase your motion. Councilman Howard made a motion to reject all bids. Councilman Weikel stated that all the Contractors know his bid and they will try to undercut him, I know about bids too he said. - 1. Meeting called to order to determine if a quorum is present. Mayor Sanchez called the Meeting to Order at 5:35 p.m. Present at the Meeting were Council Members Frank Weikel, Stuart Howard, Christina Maldonado and Irma Arizola. Councilwoman Martha Guerra was absent.
- 2. Pledge of Allegiance. Pledge of Allegiance was led by Mayor Sanchez and members of Council.
- **3.** Approval of Minutes for May 7, 2013 & May 16, 2013. A motion to accept the Minutes as stated for the May 7, 2013 meeting was made by Councilman Stuart Howard and he was seconded on the motion by Councilwoman Irma Arizola, all were in favor so motion carried. A motion to approve the minutes of May 16, 2013 was made by Councilwoman Christina Maldonado and she was seconded on the motion by Councilman Stuart Howard, all were in favor so motion carried.
- 4. Citizens Comments. Citizen Janet Kreuger from Hecho en Encinal wanted to address two issues before Council. Mrs. Kreuger stated that Hecho en Encinal was dissolving as an organization, but the Library and the Community Access computers would still remain. The Library is funded by the County and it's supported by the Alexander Memorial Library in Cotulla. Mrs. Kreuger wanted to clarify another issue with the Council about a sign that was going to be funded by the City back in November 8, 2011. Mrs. Kreuger said that she had requested \$1,500.00 (fifteen hundred dollars) for the building of a sign for the Library. Mrs. Kreuger provided Mayor Sanchez and Council with a timeline for the proposed sign. Mrs. Kreuger stated that two checks were issued to the Alexander Memorial Library, one on November 2011 and the other one on February 2012. The sign was contracted to a lady from Cotulla who became ill and couldn't complete it. Mrs. Kreuger went on to say that their organization had lost the support of a local benefactor and it was then decided to disband the organization. Mrs. Kreuger stated that she had met with Dr. Jack Seals, the Superintendent for the Cotulla Independent School District and she had discussed with him the dissolution of the Hecho en Encinal organization and explained that Hecho en Encinal was housing the Library there. Mr. Seals went before the School Board and got the approval from them to replace the building where the Library was being housed and it was approved by them. Mrs. Kreuger said that she has made an agreement with a new artist to design the sign for the Library and it should be ready by October 2013. Mrs. Kreuger said that she would be returning \$6,000.00 (six thousand dollars) back to the EEDC because they can't use it for the New Library; these monies were being kept in the renovation account.
- **5.** I. City Manager's Report. Item number III Municipal Court Report under the City Manager's Report was moved up to item A. Judge Cortez reported to Mayor Sanchez and Council the revenue generated for the past three months, the amount of Citations in his court, and the implementation

of the Omni base program into his Court, this program would help the Court collect the outstanding citations by denying the defendants the renewal of their driver's license. Item IV. Police Department Report was moved up as well. The interim Police Chief Veronica Garcia spoke to Council and she said that right now her department consists of a total of three officers: herself, Officer Christina Espinoza who is currently on medical leave and Officer John G. Payle. Interim Chief Garcia stated that she would like to request permission from Council to sell the grey unit because it would cost more to repair it than to go out and purchase a new one according to what the local mechanics have told her. Interim Chief Garcia asked Council if she could acquire some equipment such as ballistic vests and assault rifles, she went on to say that Law enforcement agencies are no longer using shot guns. Interim Chief Garcia said that she felt that the department needed these items because this is a high traffic area for illegal smuggling and drugs. Garcia said she would like to request the purchase of a digital camera to take photos of accidents, a fingerprints kit especially for the recent burglaries. She told Council that she would also like to request a first aid kit and a spotlight for the units. Officer John Payle presented Council with pictures of the items being requested, and he told Council if they had any questions to let him know, he went on to say that the AR15 assault rifle has replaced the shot gun throughout the United States. Officer Payle said that the price for the rifles with carrying case, ammo & mags and the aiming device would be approximately \$4,900.00 (forty nine hundred dollars). City Consultant Ashley Eddington wanted to inform Council that when the 2012-2013 budget was set up there were positions created within the department that have not been filled. City Manager Davila said that she would like for Council to consider the safety of our Officers. Officer Payle explained the ballistic vest to the Council by saying that the vest does not have to be fitted, anybody can wear it, the cost of the vest is \$2,300.00 (twenty three hundred dollars) and you can buy four of the regular vest for the price of one of these. Officer Payle explained to Council that he was approached by two individuals who are the main suspects in a robbery, I was parked two blocks away and one of them asked why I was following them, you two are the only ones walking around at night, and when they got close to me I pulled out my baton and they pulled back. Interim Chief Garcia announced that Officer Payle had been promoted to Captain. Mayor Sanchez said that now we would resume the City Manager's report. A. 1st Annual Cinco de Mayo Celebration. City Manager Davila said that we had a great turn out for the Cinco de Mayo celebration and we had donations totaling \$2,350.00 (two thousand three hundred fifty dollars) which were donated by: Hector Hall, Wilbur Tenery from Tenery Welding, Tom Benavides from Los Angeles Cattle, Breakwater and Seca Engineering, we also had Southern Distributors donate the tubs for all the drinks. The total portion that the City contributed to the festival was \$661.76 (six hundred sixty one dollars and seventy six cents). D. Update on Child Crossing on IH Business 35. City Manager Davila said she had contacted TX. Dot regarding the child crossing concern on Main Street and the response from them was that there were not enough children utilizing that street during school hours. City Manager Davila asked Encinal Elementary Principal Mrs. Debra Weikel to please write a letter to TX. Dot regarding the concerns for the children using Main Street to get to school so we could get some additional support to try and get a Child Crossing sign. City Manager Davila stated that currently our Police Department does the School Patrol on mornings and evenings but now we would like to ask Constable Maldonado if he can begin doing this so that the Police Department can start to focus on Main Street during the school hours. B. Update on possible Speed Bumps. City

Manager Davila asked Mr. Glen Boultinghouse about the location of the speed bumps he will be donating to the City. Mr. Boultinghouse said that he would be donating speed bumps on Tejas Street and the other one would be located by the School. C. Update on side-walk project. City Manager Davila said that Mr. Craig Rosenstein from Lewis Energy came by the City Hall and said that he had already spoken to Leyendecker Construction on beginning this project but that there had been some minor delays due to all the rain we had been having. The side-walk project would begin at the school and would end on Front Street. E. Information on Possible Beautification Project. City Consultant Ashley Eddington spoke about receiving a flyer for a grant award last year and he said that basically if the City would create a beautification program where you would add flowers, foliage, walks and things like that the City would qualify for a grant award. Consultant Eddington said that our beautification would consist of a .06 mile walking trail along North Front Street but in order to utilize that area we would have to get permission from the rail road but if we don't get permission from them we could still use a five foot easement along that path. Consultant Eddington said the path would contain Palm trees and the beautification program would include the Veteran's Memorial which was currently broken. City Manager Davila said that Mr. Craig Rosenstein from Lewis Energy had offered to pay for the repairs of the Veterans Memorial once an estimate had been done. Consultant Eddington said that the foliage that would be planted along the rail road trail would be wildflowers such as bluebonnets and cactus and the trail would run from Front Street all the way to the County Park. F. Encinal Partner's Animal Shelter- Budget Update. City Manager Davila announced to Council that we had received the money from the County to begin the animal shelter. Manager Davila said that we could start buying the equipment for the shelter and we are almost done cleaning the Transfer Station because the Public Works guys have done a great job cleaning up the area. Manager Davila said that hopefully in about a month or month in a half we can get the Animal Shelter going. Consultant Eddington stated that the Animal Shelter would take about \$16,725.00(sixteen thousand seven hundred and twenty five dollars) to complete and that would include the kennels, a gutter system, the electrical work needed and any other items needed to complete it. City Manager added that the County is requiring the City to turn in a financial update to the County every quarter. G. Update on Solid Waste Grant-Training on June 13& 14, 2013-Budget Update. City Manager Davila said that Captain Payle, Interim Chief Garcia, Pablo Esquivel and Mayor Sanchez had attended a training where they received Certification for illegal dumping and they can also give citations for City Ordinance Violations and for Code Enforcement as well. Consultant Eddington said that we have to adhere to the budget for the Solid Waste Grant. City Manager Davila presented Mayor Sanchez and Council with a folder that included the sanitation aging report but that they would have to leave it behind when they left because there is a lot of private information involved in this report she wouldn't want it to leave the City because it included personal information. H. Report on Monthly Bills. City Manager Davila said that the total amount of the bills for the month of June was \$27,310.13(twenty seven thousand three hundred ten dollars and thirteen cents) the amount also includes payment made to the EEDC for the sales tax. I. Bank Account Balance Report. City Manager Davila said that as of June 24 our balance on our accounts is \$68,033.95(sixty eight thousand thirty three dollars and ninety five cents). There is a Municipal Court account, General Funds account, Payroll account and two savings accounts. There is a total of \$59,000.00(fifty nine thousand dollars) in our savings account. Consultant Eddington mentioned that one of the reasons were in such great shape is because when the City Council adopted the budget for '12-'13 we put in a reserve requirement and as we engage in new projects the City will need to have a "sinking" fund to make sure we are able to meet our obligations. J. Sanitation Aging Report. City Manager Davila said that the report covers March, April and May and we do bill out but we don't collect everything. City Manager Davila said we collect about seventy five percent on our Sanitation Accounts. K. Update on Front Street Project-Budget Update. City Manager Davila said that Mr. Boultinghouse turned in a proposal to the Encinal Water Supply Corporation for laying the water lines along Front Street. City Manager Davila said that we had a meeting with the Water Department and we came to the understanding that Core Construction would turn in a proposal to repair those lines. Mr. Glen Boultinghouse from Core Construction said that there has been very little progress on the Front Street Project because of unforeseen problems. Mr. Boultinghouse said that his goal is to complete the project before the deadline. Mr. Boultinghouse commended the Water Department workers for having to deal with so many obstacles on that Front Street Project. Mr. Boultinghouse explained the proposals he had made to the Encinal Water Supply Corporation involving the replacement of the fifteen hundred feet of water line that needs to be done before completing the Front Street project, the proposal included a 4 or 6 inch line whichever the Encinal Water Supply Corporation thought would be best and he did say that this was not a money making proposition. Mr. Boultinghouse said that he had already run a temporary line since Monday so that we wouldn't have as many setbacks out there on that Street Project. City Manager Davila thanked Mr. Boultinghouse for all he has been doing on the project and she acknowledged that she knew that he has been doing a lot of free work over there. President Elena Rodriguez from the Encinal Water Supply Corporation asked the public to please bear with the Water Supply right now because she knows there are a lot of upset people. II. Accountant/Consultant Report. A. Budget to Actual Report. City Manager Davila asked Mayor Sanchez if she could get a motion from Council to move up agenda item 8 to II B. Councilman Frank Weikel made a motion to move up item 8 to II B. and he was seconded on the motion by Councilman Stuart Howard, all were in favor so motion carried. Consultant Eddington discussed the Front Street project draws with Council, he said we have had a total of two draws one for \$20,748.00(twenty thousand seven hundred forty eight dollars) and one for \$5,500.00(five thousand five hundred dollars) and we have a pending draw of \$65,652.00(sixty five thousand six hundred fifty two dollars). Consultant Eddington told Council that when he first came to the City I did a financial needs analysis and we had several things that we needed to upgrade which included our accounting system, our internal controls, put a budget together and have it approved. Consultant Eddington discussed the Budget to Actual Report with Council and he said that what it includes is all the different class categories, how much money we have budgeted and how much we have spent. Consultant Eddington covered page five of the report and he told Council that the actual income received by the City to date was \$563,513.67(five hundred sixty three thousand five hundred thirteen dollars and sixty seven cents) and the budget amount was \$539,000.00 so right now we have \$24,000.00(twenty four thousand dollars) more than what the budget accounted for. Eddington went on to say that some of the reasons why this happened is because the Municipal Court had a warrant round up and we also have had a lot of permits; this report is from October 2012 to May 2013. This report is critical to us because we will be doing our budget workshops in July. B. Audit Update -2010-2011 2011-2012. Consultant Eddington said there

were no exceptions on the audits and I would recommend that we adopt them. Item 8. Discussion and Action needed to approve 2010 & 2011 Fiscal Year Audit. City Manager Davila stated that we needed a motion on this item. A motion to approve the Audits was made by Councilman Weikel and he was seconded by Councilwoman Maldonado, all were in favor so motion carried. C. Sales Tax Audit Update. Consultant Eddington stated that the City was selected to be audited by the State Comptroller's Office. The audit was conducted at Consultant Eddington office and the City Manager was present for the audit. Mr. Eddington said that the auditors agreed on the way the information was put together and on how we were accessing the tax. Mr. Eddington said that the auditors usually go back seven years but we convinced them to only go back four years. Mr. Eddington stated that we will have a liability but we don't know how much that will be but they will allow us to make payments.

- **6. Discussion on Mayor, Mayor Pro-Tem and City Council Members.** City Manager Davila stated that we are going to keep everything as it is right now and this is a discussion only item.
- 7. Discussion and Action on Budget Allocations on several items on 2012-2013 City of Encinal Budget. (City Accountant). City Accountant Eddington said that there were no Budget Allocations at this time.
- 9. Discussion and Action to Approve Proclamation for Veteran's Association. Discussion and Action on Veteran's Memorial. A motion to approve the Proclamation for Veteran's Association was made by Councilwoman Maldonado and she was seconded on the motion by Councilman Howard, all were in favor so motion carried.
- 10. Discussion and Action on Amendment of City Ordinance No. 11022010 establishing Rules and Regulations for Construction, Installation, Excavation and Maintenance of Utilities with City of Encinal public right-of-way inside the city limits and within its ETJ; requiring permits therefore; and providing for penalties. City Manager Davila said that this item did not need a motion.
- **11.** Discussion and Action on Ordinance No. 06252013 dealing with streets, sidewalks, right-of-way and other public places. City Attorney Caballero stated that he had researched this subject and he put together and ordinance that he believes is very complete and it covers things that we might not need right now but we will eventually grow into. City Attorney Caballero said that we are always trying to catch up on things so it is his recommendation that the City adopt the ordinance. This is the first reading on this ordinance so there is no motion needed.
- 12. Discussion and Action on Open Meetings Requirement for Mayor and City Council Members. Discussion and Action on closed Session Requirements. (Possible Closed Session). City Manager Davila let Councilwoman Maldonado that she needs to view her Open Meetings video on the Secretary of State's website. City Attorney Caballero stated that they have 60(sixty) days to complete this course.
- **15.** A motion to move up item 15 to 13 was made by Councilman Howard and he was seconded on the motion by Councilwoman Arizola, all were in favor so motion carried. **Discussion on update on**

City Hall project. City Manager Davila said that we have turned in our paperwork, our drawing are being done by our Architect Mr. Guajardo and he should have those completed by the third week in July. Manager Davila said that we are currently waiting for USDA to send us our Letter of Condition and then we can move forth on that.

- 13. Discussion and Action on Agreement between EEDC and Hecho en Encinal dated October 25, 2005. (Possible Closed Session)
- 14. Discussion and Action on the EEDC's Board management of the affairs of the corporation, restructuring and clarification of member(s) and roles of each. (Possible Closed Session) A motion to go into Closed Session to discuss items 13 & 14 was made by Councilman Weikel and he was seconded on the motion by Councilman Howard, all were in favor so motion carried. Mayor Sanchez, Council, and Staff retired into closed session at 6:45 p.m. A motion to reconvene was made by Councilman Weikel at 7:25 p.m. and he was seconded on the motion by Councilwoman Arizola, all were in favor so motion carried. City Attorney Caballero stated that Hecho en Encinal was dissolving and what are we going to do with the money and also the Library would like to get some type of funding from the City. City Attorney told Ms. Janet Kreuger that since the EEDC can't give money to the Library, according to what you said, then I recommend that you write a letter returning the money in the form of a check made payable to the EEDC. City Attorney Caballero went on to say that as far as the City giving any money to the Library because its not on our agenda we can't do anything with it right now, however if you would like to request funding I would encourage you to contact Velma and have her put it on the agenda. (Attorney Caballero was addressing Ms. Janet Kreuger) City Attorney Caballero asked Council for a motion to table Item number 13, a motion to table was made by Councilman Howard and he was seconded on his motion by Councilwoman Maldonado, all were in favor so motion carried. Councilman Howard made a motion to restructure the EEDC Board, as part of that reconstruction, Mr. Mancha be removed as a Director of the Board and Officer of the EEDC, he was seconded on the motion by Councilwoman Maldonado, both were in favor so motion carried, (Councilman Weikel and Councilwoman Arizola both abstained from voting.)
- 16. Adjournment of the Meeting. A motion to adjourn was made by Councilman Howard and he was seconded by Councilwoman Arizola, all were in favor so motion carried. Meeting ended at 7:30 p.m.

A motion to move up items twelve and thirteen was made by Councilwoman Irma Arizola and she was seconded on the motion by Councilwoman Martha Guerra, all were in favor so motion carried. Item 12. Consideration and Approval of a Resolution by the City Council of The City of Encinal, Texas authorizing and approving Publication of Notice of Intention to Issue one or more series of Certificates of Obligation, and providing for other matters in connection therewith. (Presented by Bond Counsel) Item 13. Discussion and Action on approval of Loan Resolution for USDA City Hall Project. Mr. Juan Aguilera a Bond Counsel Attorney from Escamilla and Poneck, LLP said he would like to start by introducing item number 13 an approval of Loan

Resolution for USDA City Hall Project. Mr. Aguilera asked City Manager Davila if she had explained the loan to Council and she replied that it had been discussed during the Budget workshop and that the interest rate could go up to 3.5 percent or go down as low as 2.7 percent. Mr. Aguilera added that on the Letter of Condition from USDA that the loan amount is not going to exceed 3.5 percent and at the time of closing what the USDA will look at what the interest rate is at that time and if it's lower than 3.5 they are obligated to give you the lower rate. Councilman Frank Weikel asked if that rate was locked in. City Manager Davila responded that yes it was. Mr. Aguilera stated that the resolution says that the Council is wanting to proceed with the Loan Agreement but he wanted to make sure that at this point you are not approving any financing other than agreeing to move forward in that direction. Mr. Aguilera stated that on item number twelve is the process that USDA and State law requires in providing for the authorization of the sale of Certificates of Obligation, this resolution is required by the USDA and what your basically telling them is that you're going to move forward with the process . A motion to approve the Loan Resolution for USDA City Hall Project was made by Councilman Frank Weikel and he was seconded on the motion by Councilwoman Irma Arizola, all were in favor so motion carried. Mr. Aguilera stated that on the Letter of Condition USDA was requiring that the City issue General Obligation Bonds which are more intensive, time consuming and cost more money after speaking to the Mayor and staff it was suggested to do Certificates of Obligation instead. Mr. Aguilera stated that he has prepared the first step, the law requires that in order to issue Certificates of Obligation that a notice be prepared and that the notice be published in the newspaper of general circulation in this area and that we wait thirty days after the publication and at that the Council can if they wish issue Certificates of Obligation and that's how the USDA would like to be able to have this form of financing to be able to proceed, I have prepared for you a resolution and we sent it over to staff today and what it does it authorizes the City Secretary to proceed and publish a notice of intention that states that the City Council of Encinal will convene on September 9, 2013 at 5:30 p.m. and at that time you will consider the passage of an Ordinance of an amount not to exceed \$1, 513,000.00 (one million five hundred and thirteen thousand dollars) for the purpose of the construction and equipment

of a new City Hall and also at that time the notice states that if you proceed to issue Certificates of Obligation and you will levy as requested by the USDA that taxes will be levied in sufficient amounts every year to make your annual payments on the Certificates of Obligation. Mr. Aguilera stated that in the addition to the Certificates of Obligation utilized the law requires that a revenue pledge be used of some kind to back the tax pledge, we went ahead and pledged a lien if you approve of limited revenues from the City's Waste Management system, that every year when you set your budget the Council will meet and decide how are we going to pay this. Mr. Aguilera told Council that the first step is to authorize the City Secretary to publish a Notice of Intention and it will be published twice for two consecutive weeks and once it has been published we will come back on September 9th and at that time you will decide if you want to proceed. Mayor Sanchez requested a motion from Council. Councilman Frank Weikel made a motion to accept the Publication of Notice of Intention to Issue one or more series of Certificates of Obligation and he was seconded on the motion by Councilwoman Irma Arizola, all were in favor so motion carried. Councilman Frank Weikel asked if were getting a million and a half what happens if were under? City Consultant Ashley Eddington replied to Mr. Weikel's question by replying that in the past you could keep the money but now you have to return it back and they apply those funds as payment towards the principal. Councilman Frank Weikel asked if the bids for the project would be based on a point system. City Manager Davila stated that Architect Guajardo would be doing it differently, Joe De Ochoa from USDA will be here and Mr. Guajardo will be doing a system. Mayor Sanchez resumed item number five, City Manager's Report. City Manager Davila stated that the Animal Shelter is seventy five percent completed and we should be getting our cages on Thursday and the electrician will be doing all the work on Friday and hopefully we can have the ribbon cutting the second week of September. City Manager Davila stated that she has not worked on the monthly bills yet because this Friday we will get the sales tax. City Manager Davila said that the Front Street Project is fifty four percent complete and it should be done by September 30th. City Manager Davila told Council that we sold the Grey Police Unit for \$2,000.00 (two thousand dollars) plus they gave us a tail gate for the Code Enforcement truck and we sold the Sanitation F250 for \$1,00.00(one

thousand dollars) and we opened a new equipment account with the money also Lewis Energy is looking into buying our Compactor. City Manager Davila stated that we were trying to get the Fire Truck repaired because in order for the County to pay for it you would have to fix it first and then bill the County so I called Craig Rosenstein from Lewis Energy and the head mechanic for Lewis Energy said they would take care of the fire engine because it's been broken for three months already. City Manager Davila spoke about the Shell Conferences being held in Carrizo Springs at Middle Rio Grande and she said that grants would be available to those who attend the conferences and she also mentioned that all members of Council were invited to attend. Sales Tax Audit Report: Consultant Eddington told members of Council we had a sales tax audit for our taxable services for our trash the auditor wanted to know how much we hadn't reported, why we haven't reported and how we are paying it back. Mr. Eddington went on to say that we hadn't been reporting sales tax because the previous administrations believed we were tax exempt, after finding out we immediately filed and started collecting sales tax. Consultant Eddington recommended to Council that in order to pay the sales tax that we are going to owe we could do a twenty five cents increase on the sanitation accounts or we could also make payment arrangements to pay it off. Consultant Eddington said that they have submitted the 2011-2012 audits to Flores. City Manager invited all Council members to the City Hall ground breaking on August 19, 2013.

- 6. Discussion and Action on City's contribution to Immaculate Heart of Mary Catholic Church. City Manager Davila said that the church was requesting two hundred dollars for their annual Jamaica. A motion to donate the money to Immaculate Heart of Mary Church was made by Councilman Frank Weikel and he was seconded on the motion by Councilwoman Martha Guerra, all were in favor so motion carried.
- 7. Discussion and Action on City's contribution for School Supply drive for Encinal Elementary School. Mr. Linares explained to City Council that they recommend that the Encinal Water Supply Corporation have at least fifty four fire hydrants throughout the City and that all the water lines should be at least six inches in diameter, he also mentioned that the East side of the City was evaluated because of the possibility of that area being developed. City Attorney Juan Caballero asked Mr. Linares "how would this assessment benefit the City?" and Mr. Linares replied that to obtain a grant it's easier to apply for one once you have an assessment or evaluation already in

Ms. Davila said that she had sent him an email letter which stated that the Contractor is obligated to show that he has paid all his contractors and we must have a sworn affidavit from all his contractors to prove that he has paid all of them. City Manager Davila stated that she had already bought the gifts for the Pre-Kinder and Kinder grades and we have received several donations from locals like Wilbur Tenery, Hector Hall, Lewis Energy and others. City Manager Davila stated that she would like to use some of these funds to purchase heaters for the elderly. City Manager Davila said that she had sent a letter to the owner of the Main Street property that was cleaned and it was paid with funds from the EEDC, when the owner pays the money will be placed back in the EEDC Account. City Manager Davila stated that we got a \$12,000.00 grant for Recycling for the upcoming year. Mr. Eddington wants to purchase recycling bins for the Citizens of Encinal and we will work with the Encinal Elementary School children as well. Mr. Eddington said it would be a great project to do with the kids. Mr. Eddington said that other Cities are combining their recyclables in order to have them picked up and that would be something we could look forward to in the future. Mr. Eddington discussed the Financial Statements with the members of Council.
- 6. Discussion and Action on City Hall Project Invitation for Bids and update on closing instructions. City Manager Davila gave members of Council the Invitation for Bids for the New City Hall posted in the San Antonio Business Journal and the Frio-Nueces Current. City Attorney Juan B. Caballero spoke to the members of Council regarding how the bids would be accepted for this project. City Manager Davila told

members of Council that she hopes that the bids come in under budget so that we won't have to rebid the project. City Manager Davila stated that the plans will be available at the City Hall here in Encinal and at the Eddington Group in San Antonio because Mr. Guajardo didn't want to have the plans in his office.

- 7. Discussion and Action on Final Reading AMENDING BUILDING CODE ORDINANCE NO. 2013128 (ADDING TO ORDINANCE NO. 20121024A1) AND APPROVING SCHEDULE A (BUILDING AND PLANNING FEE SCHEDULE). City Manager Davila told members of Council that we had some issues with a contractor that s building apartments here in town. City Manager Davila told members of council that the ordinance is being amended to amend the fee schedule to match the ordinance. City Attorney Caballero said that the revised ordinance will include all the fees. City Manager Davila read Members of Council the letter that was sent to Mr. David Monnich who is in charge of the Encinal Development apartments. A motion to approve the fee schedule was made by Councilman Howard and he was seconded on the motion by Councilwoman Guerra, all were in favor so motion carried.
- 8. Discussion for full payment of Sales Tax Audit Balance to the Texas State Comptroller's Office (Possible Closed Session Pursuant to Authorization by Title 5, Chapter 551, of the Texas Government Code) presented by City Attorney. City Accountant Eddington addressed Council about the discussion with the Comptroller's Office about entering a payment agreement to pay of the Audit balance but there would be an automatic lien put on the City. For the record City Attorney Caballero stated that this was item number eight and it was a discussion only item. City Manager Davila stated that the amount was \$17,622.59 (seventeen thousand six hundred twenty two dollars and fifty nine cents). City Manager Davila explained to Council that if we would have gotten a Lien put on the City it would have affected the City because we would have bad credit and it could affect our City Hall Project. City Manager Davila told Council that we should be getting about \$13,000 (thirteen thousand dollars) in Property Taxes plus the \$4,000.00(four thousand dollars) in Sales Tax so we could afford to take some money from our Savings Account and then replace it afterwards to avoid the Lien being placed on the City. Mr. Eddington told Council that all the money collected from the assessment would go to the Savings Account.
- 9. Discussion and Action on Approval from City Council to purchase vehicle for City Official. (Possible Closed Session Pursuant to Authorization by Title 5, Chapter 551, of the Texas Government Code) Presented by City Attorney. City Manager Davila explained to Council that Mayor Sanchez has used his truck for City business for the past five years and his truck is in bad shape. Davila told Council that she would recommend that we get the vehicle for Mayor because we get more discounts and the Mayor would be paying for it by using an allowance set up for him. Mr. Eddington explained that the vehicle will actually belong to the City but that if and when he leaves the City the Mayor could have an option to purchase the vehicle. Manager Davila stated that it is a City owned vehicle. City Manager Davila told Council that the vehicle may only be driven by City employees because it will be insured through TML. A motion to approve the purchase of the vehicle was made by Councilman Howard and he was seconded on the motion by Councilman Weikel, all were in favor so motion carried. City Manager Davila asked Council if they could please return to item 5 (City Manager's/City Consultant Report) to discuss a nonaction item with them. A motion to return to Item 5 was made by Councilwoman Guerra and she was seconded on the motion by Councilman Howard all were in favor so motion carried. City Manager

Davila just received a text message from the new Police Chief informing her that because of personal issues he must decline the offer made to him. Manager Davila explained that we are currently having some problems with our current bank. A motion to authorize the City Manager to change Bank Institutions was made by Councilman Weikel and he was seconded on the motion by Councilwoman Guerra, all were in favor so motion carried.
- 11. Discussion on Ruiz & Associates Surveying, Inc. contract regarding Land Reform Project. (Possible Closed Session Pursuant to Authorization by Title 5, Chapter 551, of the Texas Government Code) Presented by City Attorney. A motion to go into executive session was made by Councilman Weikel and he was seconded on the motion by Councilwoman Guerra all were in favor so motion carried. Council retired to executive session at 6:55 p.m. A motion to reconvene from executive session was made by Councilman Weikel and he was seconded on the motion by Councilwoman Guerra, all were in favor so motion carried. Council returned to regular session at 7:08 p.m. Councilwoman Arizola joined the Council while they were in executive session.
- 12. Adjournment. A motion to have a Special meeting on Monday December 16th at 9:00 a.m. was made by Councilman Weikel and he was seconded on the motion by Councilwoman Guerra, all were in favor so motion carried. A motion to adjourn was made by Councilwoman Arizola and she was seconded on the motion by Councilman Weikel, all were in favor so motion carried.
