Special Meeting Minutes

January 27, 2015

- 1. *Meeting called to order to determine if a quorum is Present.* Present were Council Members Stuart Howard, Roberto Aldaco, Irma Arizola, Martha Guerra, and Christina Maldonado.
- Pledge of Allegiance. The Pledge of Allegiance was led by Mayor Sanchez and the City Council.
- 3. *Discussion and Action on approving minutes of December 2, 2014.* A motion to approve the minutes as states was made by Councilwoman Guerra and she was seconded on the motion by Councilman Howard, all were in favor so motion carried. Councilman Aldaco abstained from voting because he was not present at the previous meeting.
- 4. Citizens Comments. There were no Citizen's Comments at this time.
- 5. *Discussion on Frank Weikel's resignation for City Council Member.* City Manager Davila read Mr. Weikel's resignation letter to the Council. Mayor Sanchez thanked Mr. Weikel.
- 6. *I. City Manager's/City Consultant Report.* City Manager Davila told Council that Chief Nichols from the La Salle County Fire Department would be here on Thursday to test the fire hydrants this would help homeowner's with their insurance, depending on their score of course. Consultant Ashley Eddington told Council that he would be submitting the 2013 audit to the Auditor tomorrow. Consultant Eddington told Council that next month we will have our first financial quarter review.
- 7. Discussion and Action on Inter-local Agreement between the City of Encinal and TML Multistate for the Employer Member Benefit Fund Contract. City Manager Davila explained to Council that this agreement was for the employees insurance. City Manager Davila told Council that the renewal period starts in May and they can sign up in April. The Inter-Local Agreement would allow TML to provide insurance for the employees. A motion to accept the Inter-local Agreement between the City of Encinal and TML Multistate for the Employer Member Benefit Fund Contract was made by Councilwoman Guerra and she was seconded on the motion by Councilman Howard, all were in favor so motion carried.
- 8. Discussion and Action on TML-AMCC Elected Officials' Conference for any interested City Council Members to be held on February 12-14, 2015 in San Marcos, Texas. City Manager Davila told Council that if anyone is interested in attending please advise her so she can make arrangements to register anybody that is interested. City Attorney Caballero told Councilman Aldaco that along the same lines is education and that he needed to get on the Texas Attorney Generals website there are some trainings that you have to complete as a new Council Member and there is also a training on the open meetings act. This was a discussion item only.

- 9. Discussion on Street Reclamation Project and Commissioner's Court decision on Inter Local agreement for the Street Project for Proctor, Bonita, and Yellow Rose Streets. City Manager Davila told Council that we had attended the Commissioner's Court meeting the day before and we did speak to the Judge and the Commissioner's and we are working to get an inter-local agreement before we do any streets that are county and city so hopefully by Monday it will be approved. The only thing that came out of this meeting was that they would help us with the street and we would help them dispose of tires but I did tell the Judge that it is very expensive to get rid of tires. City Manager Davila told Council that she would recommend that we can't help them get rid of the tires but maybe the county and city workers could get together to cut up the tires and dispose them in that way. City Manager Davila told Council she would not make any agreement like that with the County until she can bring it before the Council. City Manager Davila told Council that the Commissioner's Court also mentioned something about the County lights and told Council that we have been paying for the twenty County lights for years.
- 10. Discussion on First Reading of Ordinance No. 02102015 an Ordinance to prevent tractor trailers and other large vehicles from entering or driving on any surface street without the permission of the City of Encinal. The City will be post signage on streets designating them as a no large truck zone. Failure to abide by this ordinance may result in a ticket or fine in the City of Encinal Municipal Court with amounts to be determined by the Municipal Court Judge. City Manager Davila told City Attorney Caballero that this was something to discuss with the Council and it has to do with the reclamation of the streets and people are not obeying the rules about driving on these streets that are being worked on and we have had to put railroad ties to keep them from driving on these streets. City Manager Davila told Council that we have to pay the Contractor up front and there is no respect from the residents. City Manager Davila told Council that there would be exceptions like for deliveries and things like that. City Manager Davila said that we would have to ask the Contractor how much weight these streets can handle. City Manager Davila told Council that this was the first reading.

Consultant Eddington told Council that with the recent drop in oil there have been many oil field layoffs and how that could affect us. Consultant Eddington told Council that he would have to check the budget to see if he needed to adjust it. Consultant Eddington said that any cuts would be positions that were not hired.

City Manager Davila told Council that she would be responding to the letter by advising the Commissioner's Court that they do no tell the City what Contractor to use and if the City decides to use Core Constructors it is our money and not the County's money if they didn't want Core in this Contract they could've put that in the Inter Local Agreement this is just an excuse to me that the County does not want to help or work with the City in any way they don't respect the fact that the citizens pay county taxes and that's just how I feel about it said Davila because this Inter Local Agreement was to benefit the citizens of Encinal but they would not enter into the Inter Local Agreement. City Manager Davila explained to Council that we can't pave the streets because we could get sued if we don't have an Inter Local Agreement so hopefully in the future we can pave a street on the East side of town when we have the funding for it because the streets do need a sealant still but they are way better than what we had because you can only do so much for forty four thousand dollars and when those streets were being built people didn't respect

the barricades they would drive through the streets. Consultant Ashley Eddington told the Council that we would at times have to close all the street and at that time we would do a detour for the traffic to go through. This item was to be discussed on item six below but it was a discussion item only. City Consultant Eddington told Council that he was going to cover the budget to actual but that since Mayor was not here we would wait for the next meeting to discuss it.

Judge Cortez told Council that we currently have about twenty or twenty five Citizens that have citations in my Court and I have offered them an amnesty program that if they were to come and help us with our clean up on Saturday the fourteenth and on April eighteen and it will take care of the citations that they have and they will be cleared and it will be a onetime deal for then to take care of these citations. Consultant Eddington told Council that we will have our community clean up on Friday the fourteenth and we will have two open tops available for people to throw their trash, one container will be located in front of the city hall and there will be some restrictions like you can't throw tires or oil and things like that and it will be posted on the outside of the container. Consultant Eddington told Council that there would be another container located at the old city hall and we have requested volunteers to sign up and help that day. Consultant Eddington told Council that we will also have the yard contest that will start in March and end in June, there will be three winners every month and we need volunteers to serve as Judges.

Regular Meeting Minutes

March 10, 2015

- 1. *Meeting Called to order to determine if a quorum is present.* The Meeting was called to Order by Mayor Sylvano Sanchez at 6:30 p.m. Present were Council Members Irma Arizola, Christina Maldonado, and Roberto Aldaco. Councilmember Stuart Howard was absent. Councilwoman Martha Guerra arrived at 6:32 p.m.
- 2. **Pledge of Allegiance.** The Pledge of Allegiance was led by Mayor Sanchez and Members of Council.
- 3. *Discussion and Action on approving minutes of January 27, 2015 & February 10, 2015.*A motion to approve the January 27, 2015 and February 10, 2015 was made by Councilwoman Maldonado and she was seconded on the motion by Councilwoman Arizola, all were in favor so motion carried.
- 4. Citizens Comments. Citizen Guadalupe Granados greeted Mayor Sanchez, Council and Staff and told them that he felt that there were inconsistencies in receiving and accepting applications from prospective candidates for the positions of Mayor and Council. Mr. Granados told Council that maybe they weren't aware of some of the rejections of applications for Mayor and Council positions. Mr. Granados told Council that he would challenge them to educate themselves more about what the law says about the perspective applicants for City Council, Mayor and alderman and what constitutes a rejection. Mr. Granados also suggested that Council contact TML or Texas Municipal League regarding any questions they may have. Mr. Granados told Mayor and Council that last month the Citizens of Encinal were scalded for the barricades on this new road that was being worked on by Core Constructors and yet the City did not take responsibility for not setting up alternate routes by the City or Core Constructors for the citizens that live on the south side of town.
- 5. Discussion and Possible Action on Presentation from John Carabelli on proposed Road Ranger Truck Stop on the corner of Hwy 44 & Access 35 North. Mr. John Carabelli from Road Ranger presented City Manager Velma Davila a letter of request to annex to the City of Encinal. Mr. Carabelli said that the new Truck Stop would have a Church's fried chicken and it would be a ten thousand square foot facility it would also have a taco bar and pizza bar. The Road Ranger has been in business for about forty years and the Company has just bought a Los Amigos Truck Stop in Moore and we are in the process of remodeling it. The Truck Stop located here would have approximately 80 spaces for Tractor Trailers and 80 spots for cars. Mr. Carabelli told Mayor and Council that they would like to start construction in June.

- 6. Presentation from Texas Department of Transportation (TxDot) Representative on Texas Alternative's Program (TAP). Mr. Gustavo Elizondo Jr. apologized for Melissa Montemayor not being able to attend as she had to attend a meeting. Mr. Guillermo Cuellar also presented himself to Council and he said he was a Transportation Engineer for TxDot. Mr. Elizondo said that this program is basically funding from the federal government and we oversee the federal funds and we do statewide presentations. Mr. Elizondo said that the deadline for the grant is May 4th after the grant is submitted the application will be evaluated between May and July and it will be awarded in September. Mr. Elizondo said that the TAP program is a construction only project and it is an eighty twenty cash match or in-kind and projects could be pedestrian and bicycle trails, lighting, safety related infrastructure. Mr. Elizondo explained to Council that LaSalle County was not recognized as an economic disadvantage County because of several factors including below average per capital and you must also have above average unemployment. Mr. Elizondo told Council that the application process is very important and each page must be filled out correctly including the project description and you must emphasize the key word safety and it's also important to include the location and have letters of support from the community and you must have a projected time estimate of how long the construction will take and the construction costs must be itemized. Mr. Elizondo explained to Council that there is a fifteen percent administrative cost payable to TxDot and you must have an RPIC or Responsible Person in Charge and this person must be a full time employee of the City.
- 7. *City Manager's Report.* City Manager Davila said that they would be meeting with Superintendent Dr. Seals on Thursday.
- 8. *City Consultant's Report.* City Consultant Ashley Eddington told Council that even though our Sales Tax has dropped we might not have to adjust our budget because we currently have a positive fund balance. Mr. Eddington told Council that on our budget to actual we have about seventy thousand dollars that we have not spend and it's because we have not hired for certain positions and he felt like we would not have to revise the budget but we would wait and see.
- 9. Police Chief Report. Police Chief Veronica A. Garcia started off by saying that she currently had two officers on her staff Oscar Silva who was hired on February tenth and Jesus Ibarra who was re-hired on February twenty-third. Chief Garcia said that right now she was working on a traffic enforcement report that deals with mostly rules of the road offenses. Chief Garcia covered some of the numbers for each quarter with Council and explained that it's not just about citing people but about enforcing the law and preventing accidents as well. Chief Garcia spoke to Council about the UCR report (Uniform Crime Reporting) that must be submitted every year. Chief Garcia told Council that in 2011 the reports were submitted and we had twenty four seven coverage, in 2012 report was not submitted correctly, in 2013 and 2014 everything was submitted correctly but that DPS was not going to accept them because there was no Memorandum of Understanding (MOU) between the Encinal Police Department and the

- La Salle County Sheriff's Office, the MOU is basically an agreement in writing that the La Salle County Sherriff's department would respond if there was a need for an officer in the City. Chief Garcia told Council that basically she has to start over to qualify for grants we would have to wait until 2018.
- 10. *Municipal Court Judge Report*. Municipal Court Judge Hector R. Cortez told Council that right now his Court is participating in the statewide warrant roundup and in two weeks we have collected thirteen thousand seven hundred and fifty three dollars. Judge Cortez told Council that we had an amnesty program for locals that have been issued citations and they were allowed to get their citations dismissed if they participated in a voluntary Take Pride in Your Side community service clean up and that on April eighteenth the volunteers will be back to do the second portion of their community service. Judge Cortez told Council that he will also be working on programs with the school.
- 11. Discussion on Cinco de Mayo Parade, Pageants, and Cinco de Mayo Festival. City Manager Davila told Council that they had spoken to Principal Weikel from Encinal Elementary about the possible participation of the students in the Parade and Ms. Weikel told them they had to get approval from Superintendent Dr. Jack Seals and Ms. Davila said we were just waiting on his reply about the student's participation. City of Encinal Clerk Monique Huerta told Council and those in attendance that we would be having a Pageant for Little Mr. & Miss Encinal for Pre-Kinder and Kindergarten and they will come out in the Cinco de Mayo Parade and we will also have a Miss Encinal for high school aged girls and they would also come out on the Parade and participate in the Cinco de Mayo festivities.
- 12. Discussion on Take Pride in Your Side Community Clean-up held on Saturday, February, 14, 2015. This item was discussed earlier by Judge Cortez.
- 13. Discussion on Take Pride in Your Side winners for March Yard of the Month. City Manager Davila told Council that during the EEDC meeting we had presented the second place winners their award. City Manager Davila said that the winners for the month were as follows first place went to Mr. & Mrs. Julian Alba, Jr. second place went to Mr. & Mrs. David Perez, and third place went to Mr. & Mrs. Jose Garcia, Jr. Consultant Eddington told Council that we still need volunteers to help with the judging of the next winners.
- 14. *Discussion on recycling project update*. Consultant Eddington told Council that we will start building containers for the recycling project but we had a delay because we couldn't get the cinder blocks with the etched ends so we decided that we would use regular cinder blocks with rebar and mortar. Consultant Eddington stated that they would be ordering the bins and the educational materials needed for the recycling project. Consultant Eddington said that they had contacted a vendor that was willing to come and pick up our recycled cardboard. Consultant Eddington told Council that we can now dispose of tires for two dollars per tire versus paying five dollars per tire not too long ago and for this program the customer would have to pay for the tires being disposed of up front and then their tires could be picked up.

Consultant Eddington told the audience that the City had not been declared an economically disadvantaged City because of the amount of commerce in La Salle County. Consultant Eddington said that they had spoken about building six foot sidewalks with curbs and no gutters and we have two sewers along the route that were going to have to maneuver around and is one by the Ruth Carr Center Consultant Eddington said that they had a meeting with Dr. Jack Seals (Cotulla ISD Superintendent) and he was very interested in our project. City Manager Davila said that Dr. Seals had spoken about repairing the Ruth Carr Building and building a parking lot. City Manager Davila said the sidewalk project

would start at the Ruth Carr Building and go east on Encinal Boulevard all the way to Front Street and then it would go all the way north on the newly paved Front Street to Greg Springer's property and then we would go South down Front Street to Holcomb and we would skip around the remainder of Front Street until we get to Schletze Councilman Aldaco asked if we were going to contact the Citizens that live along the route of the sidewalk to see what they think about building a sidewalk between Holcomb and Schletze street and City Manager Davila said that she would be speaking to the residents along that route and what we could do is possibly do driveways for these residents. The final decision belongs to City Council said City Manager Davila we come up with the ideas and they decide whether to approve them or not. Mayor Sanchez adjourned the public hearing at 6:42 p.m.

potential for the City. Mr. Ferguson apologized to Mayor Sanchez and Council about Mrs. Sullivan not being able to attend due to her husband having surgery and that is why her son Joe came in her place. Mr. Ferguson read a letter from Mrs. Sullivan addressed to Mayor Sanchez where she states that she is truly excited to hear of the City's growth and to accept this letter as verification of donation of two acres of land to the City of Encinal to build a park. Mrs. Sullivan asked Mayor Sanchez to recall their conversation about possibly naming the park after Mrs. Sullivan's great grandmother Rosalie Welhausen but naming the park does not affect the donation of the land please be advised that my family's donation of the two acre park site along with the right of easement to access the city site is contingent upon the City of Encinal and the County of Encinal covering the infrastructure road costs to access the park and operate it. Mr. Ferguson told Mayor and Council that they have communicated with the school district and one of the conversations we had was about possibly donating twenty acres to them to construct a new high school and maybe even a new elementary school so that you don't have to get up so early to send your kids to school. Mr. Ferguson said that Mrs. Sullivan grew up in this area and visited during her summer breaks so Encinal is like her hometown even though she lives in Fort Stockton but her home is Encinal where she has a lot of fond memories and she would like to see the city grow. Mr. Ferguson said that he has been working this property for a while and that he has a laundromat that is interested in coming here as well as another pizza place and maybe even a Danny's. Mr. Ferguson said that he looked forward to working with the City of Encinal. City Manager Davila thanked Mr. Ferguson and Mrs. Sullivan for the donation and for taking the time to be here tonight. Consultant Eddington told Mr. Ferguson that the NEZ program would work with what Mr. Ferguson was talking about and about getting the permanent residence started and that is one of the key elements of future growth to this area and to make it attractive to individuals to move Encinal and he thanked Mr. Ferguson for coming today. City Manager Velma Davila said that a Ballot Board had been established for the City election and it included Ashley Eddington and he had two clerks who worked alongside him throughout the counting of the ballots along with other individuals that were there the clerks were Ms. Ana Adams and Mary Lou Castillo Mr. Eddington will explain to you how that went about and how the ballots were tallied. Consultant Eddington stated that the Ballot Board assembled in the conference room along with a poll watcher, the two clerks, and an observer from the Secretary of State's elections division which the City did not request her but somebody else did but we were glad she was there. The ballot boxes were delivered to the early voting ballot board by the Police Department and the ballots included a custodial record of each time it was opened and initialed by each witness, the ballot boxes were emptied onto the table and aligned for the count and each ballot was read aloud, examined by each Judge and viewed by the poll watcher and the State observer and each vote was tallied independently by each member and periodically verified for accuracy during

the counting process and provisional or rejected votes were set aside for further review stated Consultant Eddington. Consultant Eddington went on to say that the results were tallied agreed upon by the board and the poll watcher and then we had mail in ballots and we had additional steps taken with the mail in packages and they were compared with the mail in request forms upon verifying the signatures each ballot was removed from the envelope and placed on the table and the ballots were then shuffled so that identity or order of the ballots and the counting process resumed as discussed earlier after completing the counting all ballots were placed in a ballot box and secured by the Police Department. There was a ballot box present in the Chambers and Consultant Eddington said that there were two secure openings for the ballot boxes one that opens the entire box and one that lets you put something inside the box and each time that it was opened we had to identify it with a tab and initial it off and this process was observed by the Police Officers. Consultant Eddington said that in the Mayor's Race Rosalinda Maldonado had 72 votes, Pedro Lopez had 20 votes, and our winner was Sylvano Sanchez with 147 votes. Consultant Eddington stated that in the City Council Race Anslema Aldaco had 44 votes, Christina Maldonado 127 votes, Roberto Aldaco 140 votes, Martha Guerra 141 votes, Carolyn Garza 91 votes, Judge Garza 98 votes, Irma Arizola 152 votes, Olga Paredes 85 votes, and Josie Poncedeleon had 83 votes. The City Councilmembers from this list are Christina Maldonado, Roberto Aldaco, Martha Guerra, Judge Garza and Irma Arizola. Consultant Eddington said that the total number of ballots given to us were 800 ballots that were ordered and once the election was over we had 532 that were on hand so we had 269 ballots to account for and we had mailed out 35 early ballots and the number of voters on election day were 230 and we had 4 testing ballots so we actually had 269 people that voted in our election and those are our results. Consultant Eddington thanked Ms. Ana Adams and Ms. Mary Lou Castillo for helping him during the counting process and he presented them with Certificates. A motion to accept the canvassing of the votes was made by Councilwoman Guerra and she was seconded on the motion by Councilwoman Arizola, all were in favor so motion carried. City Manager Davila said that we had a National Prayer Day and we had great participation and we created the banner to present to Pastor Roath in honor of the National Day of Prayer to be held every year at the City Hall. Councilwoman Guerra made a motion to move item number 17 to begin before item 9 and she was seconded on the motion by Mayor Pro Tem Aldaco, all were in favor so motion carried. Item 17. Discussion and Action on Encinal Cemetery Association and continued support. City Manager Davila told Council that it was brought to our attention last year by the Watkins family and that it was being neglected and with our Cinco de Mayo funds from last year we used it to build the new entrance gate there at the cemetery and we try to help out the Cemetery Association by sending the public works guys to go help out but they have other things to do so we have been hiring individuals from the community to cut the grass we do have some support from the County but with all these rains they are very busy as well so our suggestion was to speak to the Cemetery Association. Because Mr. Watkins wanted to know about the money because his family had donated money for the cemetery maintenance and doing some back ground Mr. Eddington found that back in 2009 there were some money for the association.. Ms. Diane Phelps is present here she was/is a member of the Cemetery Association and there was money in the accounts back then but we don't know what happened since then. City Manager Davila said she had spoken to Ms. Phelps last week and that Mr. Watkins had spoken to her today and I did try to get hold of Ms. Finley and I left several messages for her at

her ranch and we never got a call back said City Manager Davila. City Manager Davila said that in speaking to Ms. Phelps and Mr. Watkins the City has no control over the Cemetery it does not belong to the City we do try and keep it clean out of respect to the community members laid to rest there and we don't mind hiring individuals but it is getting very costly because the grass keeps growing so our suggestion was to try and get together to see if the association could be formed again and allow community members to be on the association and ask the Cemetery Association if that was something they would like to do and have a member of the Watkins family be on that Association and Ms. Phelps had mentioned something about the City along with the Mayor as an official without a vote but that position would be for a person elected as Mayor. City Manager Davila stated that she had told Ms. Phelps and Mr. Watkins that the City didn't want the responsibility and we would prefer for the community who have their loved ones there and get a new Board so that they can be active now and that would help out the cemetery who have had several individuals willing to get a contract to cut the cemetery and maybe the Association could pay them from their funding and we haven't seen any upgrades to the Cemetery and as of 2009 there was around seventy thousand dollars in the Association bank accounts in two different bank accounts. It is not the City's business to get into what the Association is doing but we would like to see if the association could form a new board and try and get new community members to be on that committee. Mr. Trace Watkins said his family goes back years and years in this community and was responsible for the fence that goes around the cemetery and what we would like to try and do is try to get the association back on track to get it back to where it's supposed to be and be taken care of the way it's supposed to be and using the money the way its supposed to be. Mr. Watkins asked Ms. Phelps what her position on the Board was. Ms. Phelps said that before anything can get done we need to have an association meeting first of all let me explain that the cemetery association is not a privileged club it includes everybody in town that has his family members there or who expects to be buried there one day and they are all invited to come to any meeting they have, we always get very poor attendance but I do think that before we can make any kind of decisions the people that were on the association should try and get together and have a meeting and I agree that it's the Associations responsibility to try to maintain the cemetery and not expect someone else to do it. Ms. Phelps stated that the Cemetery is an entity in and of itself it does not belong to the City or the County it has its own charter. Mr. Watkins asked Ms. Phelps if she understood what his position was here my uncle left a considerable amount of money for that cemetery to be taken care of and we feel it's been abused and until somebody starts making phone calls or starts answering those phone calls and starts being held accountable my decision and my stance won't change. Mr. Watkins told Ms. Phelps that he enjoyed talking to her. MS Phelps said that unofficially she was a recording person and wrote minutes down when we had a meeting nobody was voted in or out. Mr. Watkins asked Ms. Phelps if she thought the association could be brought back together and Ms. Phelps said she felt it could be done but the people need to understand that they need to make their presence known at these meetings. Ms. Anna Maria Finley walked in. City Manager Davila explained to Ms. Finley that the City used the funds made at the Cinco de Mayo festival to build the new entrance gate at the cemetery and we gave them some paper work that we have that was supposed to be in those bank accounts and we have been trying to speak with Ms. Teresa Adams and Mr. Watkins has also tried to get a hold of her and we told her what it was for trying to get individuals hired to clean the cemetery not that the

£

City doesn't want to do it but we have so much work with all the rain and we only have three public works guys to be able to cut it and it can take them up to three days to cut it, we just don't know what to do anymore we don't know if the association could have a meeting and take care of it and see if the Watkins family could have a voice on that board because that's what they want.. To see what's going on with the money. Mr. Watkins told Ms. Finley that he has tried to get a hold of certain members to no avail and when he did get them on the line it was for a short time and that concerns me, my great uncle left a considerable amount of money for that cemetery to be taken care of and the only reason we are here is because we want to take make sure that money is being used appropriately and when you don't answer phone calls and say you're going to return phone call and then you don't do it well there will be concerns said Mr. Watkins. Mr. Watkins said that he wasn't here to upset the cart but to set the cart straight and get this thing back on track and it is not my wish but my great uncle's wish he's the one buried there and he asked Ms. Finley what her position was on the board. Ms. Finley said that it's been so long that she doesn't even remember what position she held it's just been so long and after Ruthie passed what was left was myself and Teresa. Ms. Finley said that the association was paying someone to go clean every month and she has since stopped I was trying to get in touch with Teresa. Mr. Watkins asked Ms. Finley what was her opinion do you think the association could be put together again and recreate the association and get this back in track we all live out of town and what we would like to do is ask for your help and support you as well and he would like the association to run on its own and be a silent partner of the association. Ms. Finley said in order to revive it who would I approach to be on the board. Mr. Watkins asked who Teresa Adams was. Ms. Finley said that Teresa Adams she and I have to co-sign checks in order for them to be written. Mr. Watkins asked if she knew why she told me approximately three or four years ago that she didn't know where the money was and that she was not on any signature cards. Ms. Finley said she and her had to co-sign checks and she kept the checkbook and whenever something needed to be written I would come and sign and the CD statements come to me but the statements from the checking account she keeps them, Mr. Watkins asked if she was still getting the statements and Ms. Finley said she had just picked up the latest statements and brought them with her. Mr. Watkins asked Ms. Finley if Ms. Adams would take her phone calls and I would like to continue this that is my priority to make sure this thing gets straightened out and I am not here to be a thorn on anybody's side. Ms. Finley said she would appreciate his help in organizing this and I would appreciate your assistance. Mr. Watkins said he was here asking for their help. City Manager Davila said that if they would like to have their meetings here they are more than welcome to use the Chambers. Citizen Rosalinda Gonzalez told Mr. Watkins that she would like to be a part of the Cemetery Association and that a lady said that she goes and throws away all the old flowers but she has a hard time getting Ms. Adams to pay her. Citizen Rosalinda Gonzalez stated that she goes to the cemetery at least three times a week because she has five family members there and she has to pay to have her family's plots cleaned and that the weeds were real high. Mr. Watkins suggested that a plaque be placed at the Cemetery with all the members name and their position within the board. City Manager Davila told Mr. Watkins that the City goes once or twice a month to clean the cemetery but the grass does grow back. Mr. Watkins told the audience that he was here to help and he would like there help as well and that he would like a copy of the financials and if there was any way to get a hold of Ms. Adams I called and left her a voicemail letting her know I would

- be here. Citizen Anslema Aldaco told Mr. Watkins that she had to ask Sanchez to lend them the tractor to fix the stone of the Holcomb's and that Mayor Sanchez didn't want to lend them the tractor. Councilwoman Maldonado told the audience that she felt that it would be better if they would discuss these matters elsewhere and City Manager Davila told Ms. Finley that they could continue their conversation in the conference room. This was a discussion item only.
- 9. Discussion on Road Ranger Abatement Package Agreement & update on start date of their Truck Stop. City Manager Davila told Council that she had received a call from the subcontractors that would be doing the underground fuel tanks and that they have also closed on their property as well so they are moving along and within a couple of weeks they should start clearing it and they will have a sign that says they will put a sign for Road Ranger and that they will be hiring for the Road Ranger Truck Stop. City Manager Davila said that the Road Ranger Abatement Package Agreement had already been approved by them and they signed it and send it back to us and it needs to be signed. City Manager Davila asked City Attorney Juan B. Caballero if Judge Michael would be able to sign because she had added him but wasn't sure if he could sign and City Attorney Caballero said no because he wasn't here when it was approved and Vicky will pass it around so everybody can sign it. City Consultant Ashley Eddington said that now we will be sending them the Texas Capital Fund that we will be doing with them and we will request that they fill in some of the information for us so we can apply for improvements for infrastructure and also this will allows us to send over the EEDC package for landscaping, façade and for signs grants.

10. City Manager & City Consultant

- a. Update on TAPS Grant Application for sidewalk project from TxDot. City Manager Davila said that we have been accepted for the first couple of rounds on the TAPS grant and now it is under review so hopefully we can have that sidewalk in front of the library that will run all the way down Encinal Boulevard down to Front Street and from there all the way to Alpine Street. Citizen Janet Krueger asked if it would run along the fence and City Manager Davila said that it would run on City right of way. Citizen Krueger was also concerned with the slope at the Library and City Manager Davila said that the engineers would be working with the slopes and level them off. City Manager Davila told Citizen Krueger that if we get approved the project would start in September. Citizen Krueger told Council that she had just gotten two car stops and that she would be installing one by the book drop area.
- b. Discussion on meeting in Fort Worth, Texas with City Administrators regarding the NEZ Program. City Consultant Eddington said that while in Fort Worth they had met with Sara Obal and Cynthia Garcia and discussed the NEZ program with them. City Consultant Eddington stated that City Council could designated a zone that could allow a residential or light industrial area to obtain abatement packages the Council can specify what type of taxes but they are mostly ad valorem (property taxes) and Consultant Eddington said we could also give abatements on permits as well. The purpose of a Neighborhood Enterprise Zone is one to encourage permanent housing, two economic development, and three betterment of the area being developed because a lot of times you have barren areas and we have a lot of agriculture actually seven hundred acres behind Love's that is undeveloped so this would encourage people to move here. Consultant Eddington said it was a very successful meeting and that Mayor and the City Manager had both attended the meeting with him.

- c. Discussion on CEF (Community Center) CDBG Grant Workshop and Grant Deadline. City Manager Davila said that they went to Austin and this grant would be to add on to the old City Hall. Consultant Eddington said that we might have to tear down the old building and start new. Consultant Eddington said that the purpose of the building would be to have a Community Center and the various organizations that benefit the City such as boys and girls club, the veterans association, the elderly program and the Ladies club could also benefit from it but the City would not be able to have offices there. Consultant Eddington said there would be offices for the various organizations but we would also have a large area for parties and events. The community center could be used like they would in Laredo, Cotulla or San Antonio and it would be for the benefit of the community said Consultant Eddington. City Manager Davila said the grant is from fifty to three hundred fifty thousand dollar grant. Mayor Sanchez asked if we could generate money from the community center. Consultant Eddington said we can't generate money from the community center but we could be reimbursed the expense for renting the center but we have not discussed that yet. City Manager Davila said that the deposits would be used to clean the building or pay the light. Consultant Eddington said that the community center is sustainable and that one day we will have a Motel here one day and we will be able to use the hotel/motel tax for certain items and one of those items is the community center. City Manager Davila said the deadline to turn in this grant is August 6th. Consultant Eddington said that they would be establishing partnerships with some of the groups that can benefit from having the community center and the more partnerships we have the more points we can get. City Manager Davila said that she had gotten together with Mr. Aldaco to try and get the elderly program so that they can form a board.
- d. *Discussion on Downtown Revitalization and Main Street Grant Workshop and Grant Deadline.* City Manager Davila said that we had applied for this grant last year but it was a last minute thing because the former Consultant didn't give us enough time so we tried to put it together in a week so we know some of the flaws of that grant. Consultant Eddington said this grant was for improvements down Main Street which would include sidewalks, lamp posts, and trees. City Manager Davila told Council that we are trying to beautify Main Street so that people can notice the difference and we do need City Council to talk to the residents along Main Street about the benefits about improving the area.
- e. **Update on City Hall water damage.** City Manager Davila said that the water damage we had at the City Hall is almost complete the grading on the side of the Police Department was not done properly and they were the ones that got the most damage and we are almost done with that.
- f. **Update on Elderly program.** City Manager Davila said that our Elderly were upset and they wanted the program but we didn't want to be taking food back and forth so we told them we could do sandwiches and cold food and they said they didn't even need the food as long as they could have the program so they are having a great time over there (Old City Hall).
- g. **Update on Election.** City Manager Davila we had a visitor on Election Day on May 9th from the Secretary of State and I'm glad she came and we got the results back from her visit and I'm glad Ms. Yanez who served as poll watcher was there as well and she saw everything we were doing and our report from the Secretary of State was clean and if anyone would like to see it we have a copy of it in our office. City Manager Davila said there were a couple of

- things that the girls who were working the election for the first time and there were a couple of issues and one was that the ballots had to be face down and the rest were just minor things nothing serious that we would get fined for.
- h. Other ------Financial related. Consultant Eddington said we would start having our budget workshops soon and we did attend a budget workshop last Tuesday and learned some real good things to put on our budgets and we have been doing everything right but we could always improve. City Manager Davila said we would be having public forums where community members could voice their opinions of course items have to be approved by Council and people do have positive and negative things to say we just want to stay away from the bickering back and forth because it's not good for us, you want to do good things for the community and stay positive and this rivalry that's been happening for years and I would like to ask Council for us to stay positive and we need to do what's best for the City and if I'm doing something wrong then Council needs to address it and let me know. City Manager Davila said that it would be impossible to pave the whole City of Encinal but we can try and go out there and see if we could find grants for the roads.
- 11. *Municipal Court ---Judge Hector Cortez.* Judge Cortez just wanted to give you an update as to what we have collected from January to April we have a total of three hundred thirty citations and we have collected thirty three thousand six hundred seventy eight dollars and sixty cents. Judge Cortez said that for the month of April we had one hundred and four citations and we have collected thirteen thousand four hundred forty five dollars and seventy cents.
- 12. **Police Department ---Chief Garcia**. Chief Garcia said that she would like to update Council on the department's productivity. Chief Garcia said that from January to May there have been three hundred ninety citations. Chief Garcia told Council that her department doesn't just do citations but they also have caseloads. Chief Garcia said that now that they have three officers she would like to focus on Public Safety and closing out the old cases.
- 13. Public Works ---- Manager Johnny Perez
- 14. Code Enforcement Division --- Officer J. Ibarra & Clerk Vicky Rodriguez. City Manager Davila told Council that Officer Ibarra and Vicky would be addressing the dilapidated buildings and high weeds on properties and they would be sending code enforcement letters. Police Chief Garcia told Council that her, Officer Ibarra, and Ms. Rodriguez attended a two day training in Eagle Pass about Enhanced Basic Environmental law and that the training summarized the difference between Criminal and Civil Prosecution and what are functions are as peace officers versus a code enforcement officer that doesn't have a peace officers license. Chief Garcia said it emphasized the most common public nuisances and what laws you can use it to enforce them. Officer Ibarra said that what they learned in this training is that they need personnel that is not law enforcement so that they can speak to the people first and let them know what our codes are and we are supposed to give them thirty days before an officer can issue a code enforcement violation and after that period we would have fifteen days before we can set court dates with the municipal court. City Manager Davila said that the purpose of the code enforcement is not only for code enforcement but for permitting also all contractors working within the city limits must have a permit to do work here.

15. *Discussion and Action on Alexander Memorial Library supply & equipment list.* City Manager Davila and Consultant Eddington along with the City Staff visited the Public Library and got to see firsthand what they need. City Manager Davila invited Ms. Yanez and Ms. Janet Krueger to

the podium to speak about the items needed at the Library. Ms. Krueger thanked Johnny for installing the book drop. City Manager Davila said she would be donating the fridge and the fax machine. Ms. Yanez told Council that there was a furniture store donating the tables and chairs. Ms. Krueger said that they were looking for donations of desk top computers with the preference of newer models. Ms. Yanez stated that they currently have four working desk top computers and that sometimes they are very slow. City Consultant Eddington asked Ms. Yanez if she knew what system they are currently using on the computers. Ms. Yanez said she wasn't sure she would have to check. Ms. Yanez told Council that they do have an IT person to help install computers if they would get some donated. Ms. Krueger told Council that on the outside improvements the fence in front of the Library is not in good shape since the high school students have been parking in front of the Library because they back up into them. Ms. Krueger told Council that she was going to be waiting on repairing the fence because she had heard that the school would be repairing the Ruth B. Carr building so she wanted to hold off on repairing it until then but just try and straighten the fence and make it safe for people visiting the library. Ms. Krueger told Council that the security light in front of the Library was out. City Manager Davila said she would get Linda to call AEP and find out if it's a security light and to see if they can turn it on. Ms. Krueger asked to see if they could get a handicap parking sign by where the book drop is located. Ms. Krueger said that they would be installing two car stops. City Manager Davila told Council that they could acquire one laptop and the other one within two months. A motion to acquire a dell lap top within the next two months was made by Councilwoman Guerra and she was seconded on the motion by Councilwoman Maldonado, all were in favor so motion carried.

- 16. Discussion Only on Alexander Memorial Library Request for support from City of Encinal for the Encinal Library. City Manager Davila said that they had contacted TML and they had told us that we couldn't help with money for salaries. City Manager Davila said that the support would have to be added to our budget. Consultant Eddington said that we have some discretionary monies so that we can purchase the computers. Consultant Eddington said that we could include the support in the budget for the Library under a blanket amount that the Council decides. Ms. Krueger said the Library will always need shelving and or a collection of books donated by the City Council. Ms. Krueger thanked Council for all their support and interest in the Library.
- 17. *Discussion and Action on Encinal Cemetery Association and continued support.* This item was discussed above.
- 18. Discussion and Action on approving Newly Elected Official Workshop on July 24 & 25, 2015 in San Antonio, Texas. City Manager Davila asked Council to please let her know ahead of time if they are planning to attend. City Manager Davila told Council that you learn a lot from these conferences. Councilman Garza said he would like to attend. City Manager Davila said that Council will be given a per diem if they attend. A motion to approve the attendance of Council to the Newly Elected Official Workshop on July 24 and 25th in San Antonio was made by Councilwoman Guerra and she was seconded on the motion by Mayor Pro Tem Aldaco, all were in favor so motion carried.
- 19. *Discussion and Action on restrictions of building around or near the City Hall located at 701 Berry Street.* Restriction may include structures and buildings built within 500 feet of the City Hall. City Manager Davila told Council that the reason we put this time on the agenda is because

of the property next door. City Manager Davila said that back in December 2nd we placed an item on the agenda that stated discussion and adoption of an Ordinance to close Laurel and Grande Street it was a discussion but I believe that everybody was in agreement to hire our engineer to do the platting on Laurel and Grande Streets and the reason for this is not that we don't want a business their but because this lady is Realtor and she is trying to sell this property and they want to build a parking space for eighteen wheelers and I don't believe that's something we want next to City Hall. City Attorney Caballero said he would like to have to look into it since we don't have a zoning ordinance. Citizen Armando Garza asked if this only pertained to within the City Limits and City Manager Davila responded yes. A motion to table the item was made by Councilwoman Maldonado and she was seconded on the motion by Councilwoman Guerra, all were in favor so motion was tabled.

- 20. **Discussion and Action on approving Notice in Frio Nueces for (CEF) Community Enhancement Fund Grant Application.** Notice will publish for two consecutive weeks in newspaper. City
 Manager Davila told Council that this was the item that they had already discussed the item
 earlier and that the deadline is August 6th to turn in the application. A motion to approve the
 CEF Grant Application notice in the Frio Nueces was made by Mayor Pro Tem Aldaco and he was
 seconded on the motion by Councilman Garza, all were in favor so motion carried.
- 21. Discussion on Community Enhancement Fund Grant (CEF) application through TDA and approving 35% cost for engineering and administrative with adm. not to exceed 16%. City Consultant Eddington told Council that these are requirements of the grant and they must be followed. City Consultant Eddington asked Council to approve the site located at 107 N. Tejas to be used for CEF Grant and to build our Community Center. A motion to approve the location and the CEF application through TDA and approving 35% cost for engineering and administrative not to exceed 16%, approving 107 N. Tejas as the site for the City of Encinal Community Center location and committing \$25,000.00 in matching funds was made by Councilwoman Guerra and she was seconded on the motion by Councilwoman Arizola, all were in favor so motion carried.
- 22. Discussion and Action on approving the following policies, procedures and requirements for TDA (CDBG) grant application for the Community Enhancement Fund (CEF).
 - a. Equal Fair Housing Opportunity
 - b. Section 3 Policy
 - c. MBE Compliance
 - d. Section 504 Compliance
 - e. Grievance Procedures
 - f. Citizens Participation Requirements. Consultant Eddington told Council that all these items are required to apply for this grant. A motion to approve the following policies, procedures and requirements for TDA (CDBG) grant application for the Community Enhancement Fund (CEF) to include Equal Fair Housing Opportunity, Section 3 Policy, MBE Compliance, Section 504 Compliance, Grievance Procedures, and Citizen Participation Requirements was made by Councilman Garza and he was seconded on the motion by Councilwoman Guerra, all were in favor so motion carried.
- 23. *Discussion and Action on summer schedule hours for the City of Encinal.* City Manager Davila told Council if approved the new hours would be until September 30th. A motion to approve the summer scheduler hours for the City Hall was made by Councilwoman Guerra and she was seconded on the motion by Councilwoman Maldonado, all were in favor so motion carried.

- 24. Discussion on Take Pride in Your Side Community Clean-up roll-off to be placed on Front & Berry from June 15, 2015 to June 27, 2015. City Manager will approve additional roll-offs as needed. City Consultant Eddington told Council that this was a discussion item only. Consultant Eddington told Council that this is the third cleanup we are having but we will not be having a cleanup day the roll offs will be placed one on Front St. by Encinal Blvd. and the other one will be located by the new City Hall and they will be replaced as they are filled up. City Consultant Eddington said that this was from a grant we got through Middle Rio Grande and TCEQ. Councilman Garza asked what items could be disposed of and City Manager Davila said the only restriction would be no tires and no refrigerators and no big household items.
- 25. Discussion and Action on approval to move forward with EEDC funding from Government Capital for City Playground to be constructed in 2015. Mayor Pro Tem Aldaco asked if there would be bathrooms at the Park and City Manager Davila replied that currently we have no plans to have restrooms because of the liability for the City. City Manager Davila said we could continue discussing this item. City Manager Davila told Council that this item had been approved by EEDC already. A motion to approve for EEDC to move forward with funding from Government Capital for City Playground to be constructed in 2015 pending the discussion of building bathroom facilities was made by Councilwoman Maldonado and she was seconded on the motion by Councilwoman Guerra, all were in favor so motion carried.
- 26. Discussion and Action on approval for city staff to seek proposals & estimates from contractors and vendors for park/playground. City Manager Davila told Council that EEDC had approved to have City Staff and EEDC Board Members seek proposal and estimates from contractors and vendors for the park/playground and that would include City Councilmembers and their input would also be included. A motion to approve City Staff, City Councilmembers, and EEDC Board Members to seek proposals and estimates from contractors and vendors for park/playground was made by Councilwoman Guerra and she was seconded on the motion by Mayor Pro Tem Aldaco, all were in favor so motion carried.
- 27. Discussion and Action on restructuring EEDC Board and accepting applications for individuals interested in becoming an EEDC Board of Director. Consultant Eddington told Council that the last time we appointed some body to the Board was back in 2013 when we appointed Hector Cortez and Linda Ramirez but as our City continues to grow I believe it's a great opportunity to let other people participate and we just had an election and we have a new Council Member, it's a fitting time to do it. Consultant Eddington told Council that thru the EEDC bylaws City Council can add or remove members. City Attorney Caballero said that pursuant to the bylaws every time you appoint someone it's for two year terms so everyone's term has expired excepting the last two appointed members. City Attorney Caballero told Council that he would suggest that they take nominations from the public as to people who are interested in serving on the board and you can make a motion to accept applications to be in the EEDC and you can set a time period of how long you want and after which time you will have a meeting and you can go into closed session to discuss who you feel should be appointed to present ideas and projects to EEDC. City Councilman Garza suggested we give twenty one days for them to turn in the applications to serve on the EEDC Board. A motion to restructure the EEDC Board and accept applications for individuals interested in becoming an EEDC Board of Director and allowing them twenty one days to turn in applications was made by Councilwoman Maldonado and she was seconded on the motion by Councilwoman Guerra, all were in favor so motion carried.

- 28. Discussion and Action on approving Public Hearing for Community Enhancement Fund (CEF) TDA Grant on Tuesday June 16, 2015 @ 6:30 p.m. Consultant Eddington told Council that the hearing is needed for this grant and once we complete the grant City Council must be present to accept recommendations from the public. Mayor Sanchez called the Public Hearing to order at 5:30 p.m.

City Consultant Ashley Eddington said that the Community Enhancement Fund TDA Grant is new to the Texas Department of Agriculture in the past they have had grants for infrastructure, real estate and certain other items but they created this fund because it helps the community's enhance their areas. Consultant Eddington said that the max amount for this grant is \$350,000.00 and the minimum is \$50,000.00 and for this particular grant we would like to convert the old City Hall into a Community Center and we have a lot of different ideas on the table so that is why we are having a public hearing. Consultant Eddington told the audience that he has had preliminary talks with the architect that built the New City Hall and he has given us some ideas like tearing down the old City Hall and starting all over and just tearing down all the walls and keeping the foundation and adding a new foundation and building upon that and a few variances of that it's all going to depend on the funding that we receive and the demolition costs to haul all that away and we were given an estimate from his brother who is also an architect and he estimated the demolition would be about twenty to forty thousand dollars but if we are able to apply and get \$250,000.00 to \$350,000.00 we could demo that and put up a new building using metal type framing we would be able to increase it from presently the old city hall is about eleven to fourteen hundred square feet we would be able to if we get a single story building we could do about 3400 or 3500 square feet with where the property is right now and we could add a parking lot that the Community Center would be able to use but because its adjacent to some other properties there would be some added overflow benefit. Mayor Sanchez asked Consultant Eddington if it would have a new foundation. Citizen Frank Weikel asked how many cars the parking lot would hold. Consultant Eddington told Citizen Weikel that he really doesn't know because he's not sure if they will build all the way to the fence line or just do a parking lot in the back or on the side. Citizen Weikel asked how big the property was and City Manager Davila replied that it goes all the way back to the entrance of the side gate. City Attorney Juan B. Caballero asked how hard it would be to do our own demolition, if you're going to spend twenty to forty thousand how much would it cost to rent a tractor, back hoe or a bull dozer and knock down the walls. City Consultant Eddington said that the majority of the costs would be to haul it away. City Manager Davila stated that she didn't feel we should demo it just add on to it or just demo the front of it because you can always pour more concrete over it. Citizen Weikel if there was a street on the side of the old City Hall and City Manager Davila replied that there was Tejas St. and the one for the Church which is Santa Fe. Consultant

Eddington told the audience that the architected said that he could build the foundation all the way to where the big rocks are on one side and go out as far as the fence line for the building and then have parking in the front, on the sides and create a parking lot in the back that the Church could utilize as well. City Consultant Eddington told the audience that on this grant we get points for forming partnerships and the Church is an NGO (Non-Governmental Organization) and I don't know if it is a 501(c) 3. City Manager Davila told the audience that we would like to get the Veterans Organization, the Elderly Program, the Girls and Boys Club, the Woman's Auxiliary and people that would like to go in there and possibly have an office there and use the office and we could also use it to have parties and you can't make money off of it but you can charge a deposit fee to cover the costs. Citizen Weikel asked what would be the capacity of the place and City Manager Davila said about three hundred people if we make it 3500 to 4000 square feet. City Consultant Eddington said that even if the max capacity would be 250 people it would be something as a City we could grow into. Citizen Debra Weikel said it would be nice and maybe even the Church could use it as well. City Attorney Caballero said that sometimes it's cheaper to demolish and build new then remodeling. City Consultant Eddington said it would be one of those things where we would have to take the bids and see what would be the best way to go. Citizen Frank Weikel asked how much would the grant be for and City Manager Davila said the max would be \$350,000.00 and it would be all grant you wouldn't have to pay it back. City Manager Davila said that the grant is due August 6th and it is a very competitive grant a lot of people want it. Citizen Frank Weikel asked how soon we would know and City Manager Davila said that we would apply for it on August 6th. Citizen Frank Weikel said that he thought it would be a great idea. City Consultant Eddington said that it would take them about sixty days or more to get back to us. Citizen Debra Weikel asked if we get less we could go in there and remodel the present building. City Consultant Eddington said that there are some issues with the current foundation and what the architect said we could do is add two or three inches on top of the current foundation and pour more concrete on top of it and rebar it but I don't know enough about foundations to see how they stabilize that. Citizen Frank Weikel said that the foundation is not structurally sound they would have to retop it with heavy duty rebar and put plastic on top so that it won't crack. Citizen Frank Weikel said that it is a small building though. City Manager Davila said that we could extend it to where we currently park and all the way to the fence and a little bit to the back. City Consulate Eddington said that he (architect) was saying you could make all the front handicap parking. City Consultant told Ms. Weikel that they would have to remove one of the trees. City Consultant said that maybe something creative could be done with the trees maybe build around them. Ms. Weikel said maybe the entrance could be located on the side of the building. City Manager Davila said the architect would be doing the drawings and we can go from there. City Manager Davila said that they were working on the grant and that they would need some help with the NGO's and we were hoping you could help us with the Veterans Organization (addressing Frank Weikel) since you are a veteran you could write a letter stating it would be nice to have an office in the building and you could start the Veterans meetings again since you all don't have a place to meet. City Consultant Eddington said that the one thing about our partners is that there has to

be some type of formalization with the organizations so I don't know if you all have a president or vice-president but I don't know that for sure I would have to check on that. City Manager Davila said that the former President was Carlos Adams but he moved to San Antonio.
